MINUTES OF THE LITTLE CALUMET RIVER BASIN DEVELOPMENT COMMISSION HELD AT 6:00 P.M. WEDNESDAY, MARCH 4, 2009

<u>Held at</u> <u>Munster Town Hall,</u> 1005 Ridge Road, Munster, IN

Chairman Dan Dernulc called the meeting to order at 6:00 p.m. Roll call of six (6) Commissioners declared a quorum. Pledge of Allegiance was recited. Chairman Dernulc thanked the visitors for coming and asked them to please sign in.

Arlene Colvin made a motion to approve the minutes of the February 4 meeting; motion seconded by William Baker; motion passed by a roll call vote of 6-0.

<u>Chairman's Report</u> - Chairman Dan Dernulc introduced Rudolf (Rudy) Sutton, an appointment of the Porter County Commissioners.

- Chairman Dernulc talked about the officers meeting with Colonel Quarles and other Corps representatives on January 28. The meeting was an opportunity for the members to meet the Colonel and learn a little of the history of the flood control project. It is hoped that these meetings will continue on a regular basis.
- A Work Study Session was also held on February 18. Notes from the meeting are contained in the agenda packet.

Action Required - Treasurer Kent Gurley presented items for action.

- Mr. Gurley acknowledged the replacement monthly budget sheet distributed to the members and explained how the budget sheet is always at least a month behind the current date. The figures are always reflected for the end of the preceding month. He referred to the unallocated budgeted balance at being \$393,013.78. He expressed concern that there are invoice commitments coming in that are not accounted for in the 90-day budget that will have to be addressed. Staff is tracking all line items.
- Mr. Gurley referred to the revised claims payable for the March meeting at a total of \$418,626.82 and made a motion to approve the claims; motion seconded by Arlene Colvin; motion passed with a roll call vote of 6-0.
- Mr. Gurley made a motion to approve the O&M claims in the amount of \$76.14; motion seconded by Arlene Colvin; motion passed with a roll call vote of 6-0.
- Mr. Gurley referred to a proposal for the creation of a web site for the Development Commission. Although the Commission is listed on the Army Corps web site, this would be a separate web site just for the Commission. He tabled the approval of the proposal at this time because there is no funding in place for this type of activity.
- Mr. Gurley referred to Chairman Dernulc for the status report on the RDA response letter. He reported that we are in the process of finalizing the letter; it will be discussed at the Work Study Session in two weeks.
- Land Management Action Bill Baker referred to the breakdown sheet of farm bids received for about 300 acres of property that is owned by the State of Indiana and controlled by the Development Commission. Mr. Baker made a motion to approve the highest bids received which were:

Area #1 – about 140 acres Plum Grove Farm \$116/acre (Second bid received was for \$100/acre)

Area #2 - did not bid due to water problems on property

Area #3 – about 86 acres) Tim & Ed Bult \$62/acre

(Second bid received was for \$5/acre)

Area #4 – about 52 acres Jerry Ewen \$75/acre

(Second bid received was for \$62/acre)

motion seconded by Kent Gurley; motion passed with a roll call vote of 6-0.

• Mr. Gurley made a motion to approve granting an easement to the IN American Water Company for the construction of a water line on Commission property. He referred to the letter from the Army Corps saying it will be in compliance with Army Corps design and construction recommendations for the flood control project. Motion seconded by Arlene Colvin; motion passed with a roll call vote of 6-0.

<u>Search Committee</u>—Ron McAhron reported that the Commission will table the hiring of an engineering firm. At the time the RFP was sent out, it was considering worthwhile. Since then, it has been reconsidered and given that we are almost done with all acquisition and the Army Corps is responsible for the engineering coordination, construction award, and construction oversight, it does not seem feasible to hire a firm. He added that each staff member has been assigned to a Commission member for reporting. Chairman Dernulc added that it was reported in the paper that the Commission is leaderless. He said that is not true. Each staff member is reporting directly to a Commissioner.

<u>Finance Committee</u> – Treasurer Kent Gurley referred to the Financial Statement for the month ending January 31, 2009. He pointed out that the Statement is about six weeks behind. On the financial sheet, it states that \$47,893 if remaining down state. As of today, there is \$44,974.60 remaining down state.

• Discussion ensued on the continuing concern for funding to complete the project to the state line. Mr. McAhron asked the USACE if the Commission is currently funded with the Corps for the 7% cost share. Imad Samara replied that, at this point, the Commission is currently funded. However, if the Army Corps receives an additional \$16 million of Federal money (they have already received \$8 million for this fiscal year), he will be sending a letter to the Commission requesting the 7% cost share for the additional money, which would be about \$1.2 million. There would be 60 days to provide that additional funding. That would satisfy the Army Corps' non-federal share to October 09. Mr. McAhron stated that the cost share does not just fund one construction contract; it is used for all ongoing contracts, design cost, recreation costs, mitigation costs, etc.

<u>Land Acquisition/Land Management Committee</u> — Commissioner Arlene Colvin deferred to attorney Casale for an update on Stage VIII. He reported that we now have either condemnation orders or started easement agreements on all properties east of the east railroad r/w lines westward to Hohman Avenue, which includes Southmoor Road in Stage VIII. He has requested the Army Corps to consider advertising Stage VIII with an option for the Southmoor residents and the two railroads (CSX and NICTD). That would give him enough time to complete the easement acquisition of the railroads and Southmoor. Several properties are contested so we will be back in court with them but we have the right to take at this point.

<u>Engineering Committee</u> — Commissioner Kent Gurley reported that he accompanied Jim Pokrajac to inspect some of the construction activities on the V-2 pipeline corridor. Work seems to be progressing. Activities will be accelerating very quickly with the pipeline relocation work. That area is on schedule; we are looking at a completion date by early to mid-April. Once the pipeline work is completed, Dyer Construction can do the sheet piling.

- All utility agreements in Stage VII are signed. The Stage VII BP utility relocation work may start as soon as their work is completed in Stage V-2. Mr. Gurley asked Imad Samara for an update on Stage VII. He replied that it is out for bids, with the bid opening being on March 24. A pre-bid meeting was held on March 3 for interested contractors. The bid award should be by the end of March with the Notice-to-Proceed to the selected contractor by April 15.
- Jim Pokrajac stated that the pump station contracts for 1A, 2B, and 2A are ongoing. It encompasses 9 pump stations. Pump Station 2A should be completed by end of 2009. Pump

Station contracts 1A and 2B have a September 09 completion date. The total of all pump station contracts is over \$26 million.

- Jim Pokrajac stated that he attended a meeting with the Lake County Highway Department on February 27. They will be meeting on an as needed basis to discuss the raising of some of the bridges in Lake County. Preliminary engineering studies have begun to determine estimated costs and design. They will seek funding after the study and report have been completed.
- Jim Pokrajac referred to the maps in the packet depicting the design overflow sections that have been identified by the Army Corps.

<u>Operation & Maintenance Committee</u> — Jim Pokrajac informed the Board members that a closure structure exercise on Chase Street took place on February 27. It took one hour and 10 minutes to close off the street; exercise went very well. This is usually the first area that floods in Gary. The exercise was part of the emergency response procedure. Mr. Pokrajac added that the Commission will have an agreement put in place with Dyer Construction to do this closing and the closing at 35th Street in the event of a flooding situation.

- Jim Pokrajac reported that the five items identified by the Army Corps as part of O&M, have been completed and the procedure for the closure installation is being written and will be the basis for the agreement with the installer. The grounding was replaced at the Burr Street Pump Station and the Marshalltown pump station was reactivated. Megger testing for all six pump stations is ongoing right now. We have met the deadline date of February 27 to have those five items completed. He will forward copies to Mr. Gurley.
- It was also reported that we should be receiving a 75% portion of the total costs incurred as part of emergency response during the September flooding. Staff has been working with FEMA to obtain this reimbursement.

<u>Legislative Committee</u> – Commissioner Ron McAhron discussed HB1716, the restructuring of the Commission from 11 members to 5 members, all of which will be Governor's appointments. It did pass out of the House and has been assigned to a Natural Resource Committee today. No hearing date has been identified in the Senate. Mr. McAhron also stated that there is \$9 million identified in this year's biennial budget for the flood control project.

• One point that Commissioner McAhron wanted to make was that there had been a perception by many residents that the residents who live on Southmoor in Stage VIII were slowing the project down because of the ongoing condemnations. That is not true. He has talked to the Army Corps several times on this and their neighborhood is being treated as an option. Having that area as an option gives us the opportunity to give the right-of-entry to the Corps, they can advertise and start construction, and we will have one year to complete all the legal portion of the condemnations. Having the option does not hold up any construction activities so Mr. McAhron hopes the issue of blame and criticism toward the Southmoor residents can be put to rest.

<u>Other Business</u> – Mr. McAhron thanked the two ladies from Munster for setting up a neighborhood meeting in Munster to talk about the project. Mr. McAhron and Chairman Dan Dernulc attended and thought it went very well.

<u>Statements from the Floor</u> - Chairman Dan Dernulc asked that statements be kept to a "polite" 3-minute time period. Statements were received from the floor by John Beckman, Mike Wood, John Mogle, Steve Enger, Bob Farag, and Jayson Reeves,

- John Beckman represented the Lake County Fish & Game Protective Assoc. He distributed a resolution declaring that the Association endorses using open lands for water storage capacity in flood events. Resolution is attached hereto as Exhibit A.
- Mike Wood commented that, considering we do not have an overseeing firm in place, the only reason the Commission has moved forward quickly is because of the pressure from the Munster residents. Commissioner McAhron replied that a management firm does not make sense at this point in time. We do not have a construction management role; only the Army Corps does. It would not be financially wise to hire an engineering firm now.
- John Mogle from Munster inquired about closure structures and the Lake County Highway Dept. considering raising of some the bridges. Jim Pokrajac informed him that the five bridges that are currently being looked at are the Northcote bridge, Kennedy Avenue bridge, and three bridges in Gary by Harrison, Calhoun, and Clark roads. They are doing a feasibility study now; a report will be forthcoming. Ron McAhron added that FEMA is presently doing remapping of Lake County where flood zones will be re-defined. Because the project is not completed yet, only minor remapping will be done in the project area. When the project construction is finished, there will be a map revision. If you are part of the project area, flood insurance rates will be re-evaluated. There will be a series of public meetings.
- Steve Enger He and other engineering residents have formed the Wicker Park Neighborhood Association. He thanked the Congressman's Office for setting up a meeting with them and the Army Corps where technical information was shared and a better understanding of the flood protection plan was shared. He said the Association is available to meet with the Commission if they can assist in any way.
- Bob Farag, owner of Griffith golf course, reiterated his dismay in working with the Commission over the years in trying to come to a suitable conclusion of what to do with his property. He was disappointed that, once we started working with him, the priority shifted and the Commission was only focusing on Stage VII and Stage VIII. After 20 years, Commissioner Ron McAhron was the only Commissioner who actually came out and met him on the property. Chairman Dernulc added that the Commission is moving in a productive direction and will continue to do so. They hope to work something out with Mr. Farag. Mr. McAhron added that he was glad to meet with him but he will not apologize for focusing on VII and VIII, based upon sheer numbers. There are several other areas that need attention, after Stage VIII is awarded, and Griffith levee is one of them. Mr. Farag's situation will come to a closure; the Commission wants everything on this project finished by the end of 2010.
- Jayson Reeves, from Gary, stated he has an engineering background and proceeded to discuss the need for the Commission to regularly meet with the drainage boards, stormwater management entities, and highway officials to better coordinate project features.

There being no further business, the meeting was adjourned. The next meeting is scheduled for Wednesday, April 1, 2009 at the Munster Town Hall.

This letter is to advise you that the Town of Munster requests that NICTD cooperate to the fullest extent possible with the efforts of the Little Calumet River Basin Development Commission to acquire an easement for the Little Calumet River Flood Control Levee across property owned by NICTD located in the City of Hammond, Indiana. This is one of the last, vital, properties necessary to complete acquisition of Stage VIII of the Little Calumet River Flood Control Project. Stage VIII will allow the construction of levees from the Town of Munster through the City of Hammond. September's massive flooding, the commission had aimed to have new leadership in place by March 1, but instead has currently halted its search efforts.

William Baker, the commission's vice chairman, on Tuesday confirmed the commission is reconsidering its

options, which include hiring another executive director instead of a firm.

Baker said not only is the makeup of the commission itself in flux because of legislation pending in the state Senate, but the existing state statute establishing the commission requires it be led by an executive director. It's no time for the commission to lock itself into contracts that may not work out, he said.

The decision is further complicated by the uncertainty of the commission's funding.

Gardner had worked half-time for the commission and half-time for the Northwestern Indiana Regional Planning Commission for an annual salary of \$80,000. In contrast, cost estimates from four firms varied widely, ranging from \$300,000 to \$2.5 million.

"It's almost like putting the cart before the horse," Baker said of making a hire without an ongoing funding mechanism, both to complete the levee system and then manage its operation and maintenance, or O & M.

Long-term O & M is not included in the commission's \$13.5 million budget estimate because under the original agreement O & M becomes the responsibility of the cities and towns along the levee once the U.S. Army Corps of Engineers completes construction.

Little Cal group 'not leaderless,' chief says

心田縣養 四八分的 **MUNSTER** | Despite published reports that state law says an executive director must lead the Little Calumet River Basin Development Commission, the organization is "not leaderless." Chairman Dan Dernulo said at Wednesday's commission meeting at Munster Town Hall:

The search for an engineering firm to oversee construction management of the Little Calumet River levee project has been suspended because hiring a firm "makes less sense," said Ron McAhron, commission member and chairman of the search committee. The U.S. Army Corps of Engineers is doing construction management of the project, McAhron said.

A search for an executive director to replace Dan Gardner, who resigned under pressure in the wake of last September's massive flooding, also is on hold.

"We (the commissioners) have split up the duties (of an executive director)," Dernulc said. "This is a business-type model. Some staff members report to certain commissioners and some report to other commissioners. And they all report to me.

"We're not running this organization where the left hand doesn't know what the right hand is doing," he said.

Wednesday's meeting was the first for Rudy Sutton, of Chesterton, who was appointed to the Little Calumet River Basin Development Commission by Porter County commissioners. Sutton is an excavating contractor and owner of R.V. Sutton Inc.

Funding sources again came under discussion at the commission meeting. If the U.S. Senate approves the \$410 billion omnibus spending bill Friday, \$16 million will be made available to the U.S. Army Corps of Engineers for the Little Calumet River levee project, McAhron said.

However, he said, the commission will have to come up with \$1.12 million in matching local funds within 60 days.

The infusion of money would accelerate phase seven of the project, which runs from north and south of the river from Columbia Avenue to Northcote in Munster:

Whether five bridges across the Little Calumet River will be raised to prevent closure during future floods is being studied by officials in Lake County, according to Jim Pokrajac, a member of the commission staff.

"Lake County is doing a study right now (of raising the bridges) and doing a

feasibility study and estimates." Pokrajac told commissioners. "Then they will go to state and federal officials for funding."

Those five structures being consid-. ered for raising are DERNULC bridges at North-



cote Avenue in Munster, Kennedy Avenue in Hammond, Harrison Avenue near Indiana University Northwest in Gary and at Calhoun Street and Clark Road in Gary.

In other business, the commission:

 Heard that work on phase seven of the levee project is progressing on schedule.

- Accepted the high bids from farmers to cultivate 300 acres along Interstate 80/94, Interstate 65, and Clay and Chase streets that is owned by the state, but controlled by the commission. Commissioners are working with the state on selling the acreage.
- Tabled any action on a Web site due to lack of funding.
- Learned that six pumping stations along the Little Calumet River have been tested.
- Heard that the Federal Emergency Management Agency probably will reimburse the commission \$35,000 it spent on flood recovery efforts during September. That is 75 percent of the costs expended by the commission during that emergency.

Munster gets plea for road closures

Resident says town's control over streets may be the solution

MUNSTER | Residents in the Wicker Park neighborhood made an impassioned plea to Munster Town Council members Monday night to close two streets to Northcote Avenue bridge traffic.

The Northcote Avenue bridge has been the subject of discussion for many months after the September rain and subsequent flooding that damaged hundreds of homes and businesses in Munster.

Munster residents blame the bridge, which spans the Little Calumet River between Hammond and Munster, for being the low point that causes flooding.

Resident Tula Kavadias said the bridge is owned by Lake County, and only the county can close or remove the bridge. However, she said state law gives the town exclusive, territorial jurisdiction over the road.

"It does not appear the county will close the bridge," Kavadias said.

"We want the town to close Northcote Avenue and River Drive to bridge traffic," she said.

Town Council members listened but took no action. Many councilmen and workers stood alongside residents who monitored the river and brought sandbags to Northcote and Columbia during the weekend rains. Munster officials said they didn't have to sandbag this past weekend.

Munster Town, Council President Michael Mellon previously has said his position is that the Northcote Avenue bridge should be closed or elevated. Last month, the council adopted a resolution in line with that.

Hammond Mayor Thomas McDennott, Jr., who is the new Lake County Democratic Party chairman, has said he wants to keep the bridge open because it is an important traffic artery.

One resident called the issue before town officials one of the "biggest challenges" they ever will face. She encouraged the council to "step up to the plate and take action!"

As the region braces for a second round of rain, Wicker Park residents Marc and Gina Campagna said they moved back into their home Feb. 28 after being out of it for five and a half months.

"I sat and watched the rain this weekend and wondered if it would rise and come into the house," Marc Campagna said. "Please close the streets. You have the support of the residents."

Meanwhile, two of the residents who spoke to the council Monday night were not pleased with a resolution that calls for the town to buy four pieces of property along River Drive.

They are 1 River Drive, 15 River Drive, 21
River Drive and 27 River Drive

Neither Robert and Ruth Krol, 1 River Drive, nor Denis and Judy Buksa, 15 River Drive, want to sell their homes.

During a break in the meeting, Munister Town Manager Thomas DeGiulio said this is the beginning process of declaring eminent domain to purchase the properties.

He said officials are convinced that even after the levee is complete, the town can not protect those four properties from flooding.

He said two owners are willing to sell and two others are not. He said no offers have been made, and the town still has to get appraisals and determine where the money will come from to make the purchase.


s rain continued to fall Tuesday, feelings of "anxiety and frustration" rose for some Munster residents along with the Little Calumet River.

Get the Little Calumet panel unstuck

he recent rains that brought flooding back to Northwest Indiana are a reminder that the ship be changed? Little Calumet River Basin Development Commission's work is urgent.

· Yet the commission is just spinning its wheels, unsure what to expect from the Indiana General Assembly.

The commission is waiting for answers to two questions:.

• How much will the state provide in its new budget for the commission's work?

• Will the commission's member-

The answer to that first question isn't going to come before the Legislature wraps up its work at the end of April. That's just the nature of the budget process as political deals are cut at the last minute.

But the commission shouldn't be forced to wait until the end of April to see how its membership might ... change.

House Bill 1716, now before the Senate Committee on Natural Resources, should be zipping through the process and become law soon.

Just look at the support this legislation has received in the region:

Meanwhile, the rains will continue to come, and the threat of floods will continue because of the unfinished levee work.

Officials representing the Army Corps and the Little Cal commission said later last week the \$1.2 million will not increase the commission's \$3.5 million share of the project's cost for each cost estimate as presented to the Legislature. It does, however, accelerate the required payment to the Army Corps to keep the project on track.

Army Corps Project Manager Imad Samara said the commission had been aware he might come back for additional dollars beyond the \$605,500 he asked for in January. That figure had been based on the president's budget of \$8

the president, he said.

The latest request should not alter the commission's budget because Samara had provided the commission with its remaining year of the project, he said.

The rub is that now the figure is final, it's due in 60 days or work on the levee project might have to be reevaluated.

Samara said he is working on the premise the commission will come up with the money,

This legislative session is scheduled to conclude April 29 but could go longer

with the state's fiscal year not kicking in until July 1.

"I'm comfortable it will be addressed," said Ron McAhron, the commission's point man with the Legislature. "This doesn't change the overall project cost?"

The House passed a one-year budget containing \$9 million toward the levee project, he said. Another bill is starting to wind its way through the Senate:



Flooding woes linger

☑ I-65 ramp to Borman closed even as river levels in region begin to recede.

Heavy rains led to the closure of the ramp that connects Interstate 65 north traffic to the Borman Expressway's westbound lanes on Wednesday.

Water began covering the road on Tuesday, and a right lane was closed while a pump tried to siphon water off the road.

The Indiana Department of Transportation said the ramp will remain closed until the water can be cleared.

Also, standing water led to the closure of the right lane of the ramps that connect the Borman's eastbound lanes to I-65 south and the Ridge Road exit.

River levels are still high, officials say, but starting to recede.

The Little Calumet River at Munster was at 11.9 feet on Wednesday, receding from a high of 13 feet on Tuesday. Flood stage is 12 feet. The Northcote

bridge between Hammond and Munster remains closed due to flooding concerns. .

The Kankakee River at Shelby was at 12.9 feet on Wednesday, according to the National Weather Service. Flood stage is 9 feet, but levees are equipped to handle waters up to 12 feet.

In southern Lake County, meanwhile, flooding was bad but it could have been much worse, officials said.

Lowell Town Administrator Susan Peterson said the town has received reports of water in people's yards, but, overall, the rains caused minimal problems.

"Back in September, it was way worse," Peterson said. No road closures were attributed to the recent heavy rains and the water appeared to be drying up nicely on Wednesday, she said.

September's flooding gave Cedar Lake officials a chance to see where drainage improvements were needed and many of those improvements since have been implemented, according to lan Nicolini, town administrator.

According to National Weather Service meteorologist Stephen Rodriguez, 4.7 inches of rain fell in Cedar Lake in September. The weather service did not have rainfall totals for Cedar Lake for this week, but its Web site said between 3.5 and 4.5 inches of rain fell in the Lowell and Cedar Lake areas in the past week.

The flood-prone Wicker Meadows subdivision fared better this time around thanks to some drainage improvements, Nicolini said, although it's still too early for a full assessment.

Not all drainage improvements identified since September have been completed, however, Nicolini added. "It's a work in progress," he said:

Cedar Creek did cross over 144th and 145th streets during this last rainfall, he said, but the roads remained passable and were marked with signs.

DeGiulio said the land involves the old Monon Railroad property running from 45th Avenue in Munster north into Hammond. Little Cal overhaul advances

Funding picture should get clearer next week

INDIANAPOLIS I If you boot them, the money will come. Region legislators pressed ahead Monday with legislation allowing Gov. Mitch Daniels to dump the 11 members of the Little Calumet River Basin Development Commission. The levee panel, blamed for fall flooding that damaged more than 4,000 region homes, would be replaced with five appointees of the Republican governor.

The commission overhaul, House Bill 1716, is seen as a first-step to securing up to \$15 million from the state to complete the levee project and repay a loan of up to \$6 million from the Northwest Indiana Regional Development Authority. But a cost range of \$13.5 million to \$15 million still is only a best guess.

"We need greater accountability. We need transparency, and we need to get this thing done," said Rep. Ed Soliday, R-Valparaiso.

State lawmakers created the commission 28 years ago to oversee construction of about 25 miles of protective levees from Gary to the Illinois border. But about two miles of levees and \$30 million in work remains.

Soliday is sponsoring the levee commission overhaul, which advanced Monday to the full Senate on a 9-1 vote of the Senate Natural Resources Committee.

He and others argue that having mayors and other regional officials make five appointments to the levee commission has dulled the panel's focus.

A House-passed version of a new state budget includes \$9 million for the Little Calumet commission, which would cover a \$6 million match needed to unlock \$24 million in federal funding.

The state Senate will present its budget plan next week. One thing is clear: The \$2 million Daniels offered in his budget proposal would not go very far.

"The \$2 million in the budget will absolutely do very little or nothing," said Sen. Frank Mrvan, D-Hammond. "This is important. What's most important is the people don't suffer again like they did in September."

NEXT LITTLE CAL MEETING

The latest updates on the Little Calumet Flood Control and Recreation Project will be available Wednesday when the Little Calumet River Basin Development Commission meets in regular session at Munster Town Hall.

The regular meeting begins at 6 p.m., preceded by a work study session at 5:30.

Among the topics will be the status of a construction contract for the final stages of the levee project and updates on the General Assembly's activities, which include addressing funding and changing the commission's composition.

The Portage-based commission is meeting in Munster to be accessible to property owners within the flood plain.

Local officials challenge gov's revamp of Little Cal Commission

MUNSTER | As the Little Calumet River Basin Development Commission meets tonight, efforts to reduce its ranks from 11 to five currently appear to be sailing through the General Assembly.

The proposal calls for all five members of the commission to be solely appointed by Gov. Mitch Daniels. The potential has raised the ire of local officials.

"The problem was the state never provided the money," Lake County Commissioner Roosevelt Allen Jr. said.

Without local input on the costly levee project, now entering its final stages, Allen said there won't be room for the state to continue to criticize local decision-making. "(Daniels) won't be able to run back here to Lake County and blame us," he said.

Like Allen, Hammond Mayor Thomas McDermott Jr. said locals have been made the "fall guy." McDermottdefended his appointee, Hammond Assistant City Engineer Mark Gordish.

"He's been on the board for years and somehow now he's the scapegoat," McDermott said, "The culprit on the Little Cal project is state government."

Official: Temporary levee work is proceeding along Little Cal

MUNSTER: The town is spending about \$700,000 for interim levee improvements to the Little Calumet River and the work is proceeding very well, Munster's town manager says.

The town began a project to make repairs to the levee where it had been breached by the Little Calumet River during September rains, damaging thousands of homes and businesses in Munster.

Following the flood, repairs were made to segments of the levee where it had been overwhelmed by the river. Concrete barriers have been installed in some segments while others have been cleaned of debris and replaced with clay. A few spots will be walled with sandbags.

Munster Town Manager Tom DeGiulio said the temporary fix involves a two-mile stretch along the river between Northcote and Hohman avenues.

Thank you for your time and a positive discussion regarding the actions necessary to proceed with bidding and construction of Stage VIII (Columbia to Hohman Avenue) of the Little Calumet River Flood Control Project. - 3. Pursuant to Article II c. and further specified in Article VI b. 4 of the Local Cooperation Agreement between the Department of the Army and the Little Calumet River Basin Development Commission (Local Agreement) will deposit in the escrow account the \$1,200,000 requested in the March 11, 209 letter to the Commission from Mr. Samara.
- 4. The Corps will offer a contract that requests completion of the line of protection for Stage VIII by December 20, 2010.

The LCRBDC acknowledges that in the event the Commission is unable for any reason to fulfill the commitments specified in items 2 and 3 of this letter, the Corps at its sole discretion may suspend the bidding process for Stage VIII until such time as the actions enumerated in items 2 and 3 are satisfactorily completed.

Thank you for your cooperation in this important effort to complete the levee construction as expeditiously as possible.

- Whereas: high quality wetlands provide excellent filtering capacities, especially for sanitary discharges that occur when local sanitary districts' capacities are exceeded;
- Therefore be it resolved: that Lake County Fish & Game Protective Association endorses this approach be included in "Best Management Practices" as the Little Calumet Watershed is re-examined for major improvements to reduce flooding.
