# MINUTES OF THE LITTLE CALUMET RIVER BASIN DEVELOPMENT COMMISSION HELD AT 6:30 P.M. THURSDAY, MAY 7, 1992 AT THE COMMISSION OFFICES 8149 KENNEDY AVENUE, HIGHLAND, INDIANA

Chairperson Arlene Colvin Called the meeting to order at 6:35 p.m. Eight (8) Commissioners were present. Quorum was declared and guests were recognized.

The minutes of the April 2nd, 1992 meeting were approved by a motion from Clyde Baughard; seconded by William Critser; motion passed unanimously.

Mr. Gardner referred to the letter contained in the packet from IDNR to Col. Inouye regarding Section 215 requirements. Based on several meetings, there has been some changes and the concept has moved almost totally parallel to the Corps long range plan. This will maximize credit of the project to the Commission. A basic cost estimate was provided by DNR. The work can be done under the existing Corps permit. Corps should be requested now to oversee the project. A grant from SEMA may be available to offset some cost. The remaining issue is one of funding. Mr. Gardner stated that we need to meet with the Governor and staff to talk about cash flow to the Commission.

Commissioner George Carlson still expressed concern about raising the tieback with the C&O Railroad. He was concerned about whose responsibility it was to remove the embankment after the project is in place.

Funding the levee in this area was again discussed. Mr. Gardner assured Commissioners that a future funding commitment must be in place before the Commission will make a commitment for funding.

By the next meeting, the design work of the levee should be complete. Mr. Gardner will stay in contact with all entities and pursue setting up a meeting with the Governor's Office.

Finance/Policy Committee - Committee Chairman Clyde Baughard presented the financial status report for April as well as the claims. Mr. Baughard made a motion to approve the pending claims; motion seconded by Charles Agnew; motion passed unanimously. Mr. Baughard also informed the Commission that the Corps has withdrawn \$120,000 this month from the escrow account.

Land Acquisition Committee - Chairman Charles Agnew made a motion to fund an air conditioning unit from Myers Heating & Cooling to be bolted to a concrete pad at Howard & Sons. Myers gave the lowest quote to the Commission. The motion was seconded by George Carlson; motion passed unanimously. After discussing the issue of whether a chain link fence should be installed around it for security reasons, Mr. Agnew made a motion to get the best quote on fencing and then secure fencing; motion seconded by Clyde Baughard; motion passed unanimously.

Mr. Agnew made a motion to increase the offered price on DC286 from \$2,100 to \$3,000; motion seconded by Clyde Baughard; motion passed unanimously.

Mr. Agnew made a motion to release the remaining 10% retainer that was held back to Dyer Construction Company. The ConRail culvert replacement project is now complete. The engineer, Tenney Pavoni, has assured the Commission that work has been satisfactorily completed and surrounding area all cleaned. Motion seconded by Nathaniel Leonard; motion passed unanimously.

Project Engineering/Construction Committee - Mr. Gardner referred to the Commission draft letter contained in the packet to be sent to the Corps regarding our request for the geographic project area be designated Lake County, since it most fairly represents the catchment area for application of labor and construction regulations and minority participation goals. Mr. Baughard made a motion to send the letter; Mr. Agnew seconded the motion; motion passed unanimously.

Mr. Flora from R.W.Armstrong talked about individual meetings held on April 28th and May 5th with some of the affected utilities. Topics of discussion were the thoroughness and completeness of utility information as shown on Corps maps; the impact of the project on individual utility lines and possible remedial action needed for each; easements, permits, deeds available for utility line locations; the need for utility to prepare a plan and cost estimate of the remedial action required to protect each affected utility line; and the Corps schedule for completion of said plans by the utility. Further utility meetings will be coordinated through Mr. Flora. One issue of concern is the utility schedule being so fast paced. Mr. Gardner will discuss this with the Corps.

The Pre-Bid meeting for Phase II Stage II will be held in our office on May 18th. All contractors on file with the Corps will be contacted.

Mr. Gardner informed the Commission he is working on setting up a meeting with INDOT relative to the Commission's desire for INDOT to raise Grant Street bridge over the river.

Relative to the demolition contract #3, Nathaniel Leonard made a motion for the Commission to sign the Corps right-of-entry form to signify the Commission's ownership of those lands; motion was seconded by Charles Agnew; motion passed unanimously.

Marina/Breakwater Committee - Mr. Gardner referred to the final draft report for a public marina that Abonmarche prepared for the Commission.

Discussion of sand removal ensued. Mr. Gardner stated that the contractors removing the sand are asking for permit authorization for below grade sand removal. A permit application must also be submitted to allow for road cut from INDOT. Mr. Agnew made a motion to authorize permit applications be filed requesting such; motion seconded by William Critser; motion passed unanimously.

Discussion on Commission revenue bonding was held. Concern was expressed on the pay back structure.

Mr. Gardner referred to the DNR response letter to the city of Portage. The city has provided DNR with copies of the Burns Waterway Boat Capacity Study and the Environmental Assessment, Marina Development on the Burns Waterway System. These were studies that the city had done.

Commissioner Baughard inquired about the contractor using fill from the Deep River site. Mr. Gardner informed him that in the Phase II Stage II plans and specifications, it is specified that the contractor shall use the Deep River borrow site of levee material.

There were no statements from the floor. There was no other business. The next Commission meeting was scheduled for Thursday, June 4 at 6:30 p.m.

Dear Colonel Inouye:

Ι amwriting you regarding the Development Commission's comments on the Section 215 agreement recently sent to the Commission. The Development Commission is in concurrence with all of the provisions language of the agreement, with one exception -ARTICLE 2 Manner of Performing the Work. We suggest the following languages to ensure maximum coordination and compatibility with the Federal project:

ARTICLE 2 - MANNER OF PERFORMING THE WORK. The work be executed by the cooperating agency who will advertise the contract and will award it successful bidder using the design prepared by consultant for the Indiana Department οf Natural Resources, Division of Water. Construction supervision quality including the control and testing during construction shall be provided by the U.S. Army of Engineers to insure 100% compatibility with rest of the authorized project. coordination support will be provided рÀ the cooperating agency, the Indiana Department of Natural Resources and the Town of Highland.

Additionally, the Indiana Department of Natural Resources has suggested a revision in Item (2) under ARTICLE 1 to read as follows:

(2) The new levee between Indianapolis Boulevard and the Penn Central Railroad embankment to the east will be constructed to current U.S. Army Corps of Engineers criteria.

With these changes, the agreement is acceptable to the Development Commission. We sincerely hope this agreement can be approved for signature in an expeditious manner as the final design is nearing completion and the construction scheduling needs to take place. The Development Commission hopes to award a contract to allow construction to begin as early as October 1, 1992 with completion before the end of the construction season. These time frames are driven by Federal Emergency Management Agency guidelines and commitments by State Of Indiana officials affecting Wicker Park Manor residents status. This tight time schedule necessitates immediate attention to the agreement we must sign with the Corps of Engineers. Please call me if I can assist you in any way or additional information is needed.

The acreage included the park department's former nine-hole North Gleason Park golf course in the flood plain of the Little Calumet River just west of Broadway. Flood waters kept inundating the golf course, which eventually was abandoned and turned into a soggy marsh much of the year.

Dan Gardner, basin commission executive director, said the levee system is designed to prevent major flooding.

"The plan is aimed at making Gary flood proof," said Gardner.

He said while the wetlands within the levees would be allowed to flood "there is nothing to prevent use of the property for a golf course."

The Corps of Engineers also feels a golf course would be compatible with the planned recreational use of the river corridor, said Gardner.

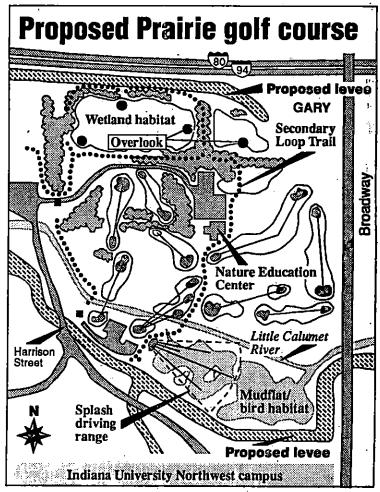
Gardner and Allen agreed that if flooding of the wetlands does occur it won't be in the summer when the golf course would be in use.

The question yet to be answered is how the golf course would be financed, said Gardner.

The Corps of Engineers can provide matching funds on a 50-50 basis for water related projects such as fish ponds and wildlife sanctuaries. Gardner said.

'I am not sure what sources there are for money for recreational use." Gardner said.

The Little Calumet River Basin Development Commission is writing you to request a modification to the Stage II Phase II bid specifications for the Little Calumet River flood control project. Based upon recent critical meeting held at the Indiana Department of Transportation offices in LaPorte on Thursday, 21, we are requesting the deletion of the road closure structures at Grant Street and Broadway in Gary. is based upon the strongly stated position of both the city οf Gary and the Indiana Department Transportation that Grant Street and Broadway are vital transportation links and need to remain open under all flood scenarios. This view will necessitate the raising/reconstruction of each bridge and the redesign of the connection with the levee protection system. recognize the hardship this late development will cause, but feel the need to accomplish the flood protection consistent with long range transportation and emergency vehicle accessibility necessitates this requested change. The Development Commission strongly concurs that the bridge raisings/reconstruction are clearly the preferred long range solution.

The Development Commission will coordinate with Lake County Civil Defense and the City of Civil Defense to assure an adequate interim closure will be in place until the bridge raising/ reconstruction projects can be scheduled. Toward that end, the Development Commission will work closely with Congressman Visclosky, INDOT, local state legislators

and the City of Gary to scope the two projects and schedule funding/construction as soon as possible to reduce to a minimum the gap in the construction timing of these projects with the Federal levee construction.

#### FINDING OF NO SIGNIFICANT IMPACT

In accordance with the National Environmental Policy Act of 1969 and Section 122 of the River and Harbor Act of 1970, the Chicago District, Corps of Engineers, has assessed the environmental impacts of obtaining borrow material from the Deep River Park for the construction of levees for the Little Calumet River, Indiana, flood control project located in Lake County.

An environmental assessment (EA) was prepared to cover the proposed borrow activities. The assessment process has revealed that the project would not have any significant, adverse environmental impacts, therefore, an environmental impact statement (EIS) will not be prepared.

The proposed activities will involve the removal of soil materials from the site and transportation, by truck, to the eastern portion of the Little Calumet River project area where it will be used for the construction of flood control levees. Levee construction activities were evaluated in a previous final EIS on this project. The proposed borrow and transportation activities will not cause significant, adverse impacts to cultural, human, aquatic, terrestrial, or recreational resources. All these factors were considered in the determination that no EIS is necessary.

Actual costs will be used to determine equipment cost for a settlement proposal submitted on the total cost basis under FAR 49.206-2(b). In evaluating a termination settlement proposal using the total cost basis, the following principles will be applied to determine allowable equipment costs:

- (1) Actual costs for each piece of equipment, or groups of similar serial or series equipment, need not be available in the Contractor's accounting records to determine total actual equipment costs.
- (2) If equipment costs have been allocated to a contract using predetermined rates, those changes will be adjusted to actual costs.
- (3) Recorded job costs adjusted for allowable and unallowable expenses will be used to determine equipment operating expenses.
- (4) Ownership costs (depreciation) will be determined using the Contractor's depreciation schedule (subject to the provisions of FAR 31.205-11).
- (5) License, taxes, storage and insurance costs are normally recovered as an indirect expense and unless the Contractor charges these costs directly to contracts, they will be recovered through the indirect expense rate.

- A. All borrow material required for this contract shall be obtained from the Deep River Borrow Site, as shown on Sheet Number 18, Sheet Reference Number C-16, of the Contract Drawings.
- B. The use of borrow material from any other site is prohibited.

#### INTRODUCTION

The Portage Port Authority and the Little Calumet River Basin Development Commission have entered into an agreement to jointly finance, construct, operate and maintain a public access marina in Portage, Indiana. To that end, a conceptual plan and feasibility study for the proposed project has been completed, excerpts of which are attached hereto. The described plan has been judged to be practical and feasible. Engineers are hereby invited to submit proposals to provide design and construction services for the proposed project.

#### SCOPE OF SERVICES

The selected ENGINEER shall be prepared to negotiate a contract to perform the following services:

- 1. Preliminary Design In consultation with the OWNER, and on the basis of the conceptual plan and feasibility study, the ENGINEER shall determine the general scope, extent and character of the Project. The ENGINEER shall then prepare Preliminary Design Documents consisting of final design criteria, preliminary drawings, outline specifications, written descriptions of the Project and an opinion of the probable Total Project Cost.
- 2. Final Design On the basis of the accepted Preliminary Design Documents, prepare final drawings and specifications to describe scope, extent and character of the work to be furnished and performed by Contractor(s). Prepare for review, execution and submission by the OWNER, technical criteria, written descriptions, and support data for any and all applications for permits and/or approvals of government authorities with jurisdiction to approve the design of the

Project, and assist OWNER in consultations with appropriate authorities. Prepare final opinion of probable Total Project Cost and prepare for review and approval by the OWNER of necessary contract agreement forms, general conditions, bid forms, etc.

- 3. Bidding Phase Services Assist OWNER in all phases of bid letting including advertising, receiving and review of bids for complete construction of the project.
- 4. Construction Phase Services Assist OWNER in general administration of the Construction contract and provide such site visitation and resident project representation as deemed necessary to assure that the constructed project is in keeping with the design plans and specifications.

#### PROPOSAL CONTENTS

Interested qualified engineers shall submit proposals to the City of Portage/Little Calumet River Basin Development Commission c/o Portage City Engineer's Office, 6070 Central Avenue, Portage, Indiana 46368 before 4:30 P.M. local time on July 2, 1992. Twenty (20) copies shall be submitted for distribution to members of both commissions. Proposals shall address the following areas of interest:

- Experience in design and construction of marinas.
- Proposed personnel to be assigned to the project showing applicable experience and proposed project team organization responsibilities.
- Proposed schedule for completion of design phase of the project.
- 4. Description of expected tasks to be completed and estimated level of effort (manhours) to be budgeted for each task (by discipline and by level of responsibility).
