The minutes of the November 4, 1993 meeting were approved by a motion from William Tanke; seconded by Robert Trelo; motion passed unanimously.

Chairman George Carlson announced he has been reappointed as the Hammond representative to the Commission by Mayor Dedelow for a 4 year term through 1997.

Mr. Carlson appointed a Nominating Committee to consist of Arlene Colvin (Chairman), John DeMeo and Robert Trelo to meet and present a slate of officers for 1994 at the next meeting.

Executive Director's Report - Mr. Gardner announced that the President signed the federal bill on October 28, 1993. He also stated that the state draw for the next cash contribution to the Corps in the amount of \$1.242 million has been drawn.

Regarding the construction phase of Wicker Park Manor, Mr. Gardner stated that an informational letter was going out to the residents living on River Drive. He highlighted the main interest points in (1) for the most part, the new levee is being built the letter: along the existing levee and construction is being staged so a line of protection remains between the residents and the river, (2) the contractor is restricted to a specified work area, the boundary of which has been agreed to by area property owners through agreement with the Commission, (3) the contractor will not begin operation Equipment will be warming up after 6:30 a.m. before 7 a.m. Generally, the contractor will operate on weekdays but some Saturday operations may be necessary, (4) landscape plantings along the new levee system will be done after the levee contract is completed. Corps will work with individual property owners along the levee to develop the types of shrubbery to be planted and (5) plans to remove portions of the old levees (facing homes) will be developed with the landscaping planting design. Mr. Gardner stressed that it not only has been frustrating to the home owners along River Drive but frustrating to us as well in regard to the legalities that have slowed down the progress. It was hoped that some substantial construction would have been started this last summer but that just did not happen.

Mr. Gardner met with the Corps who stressed that a crisis was looming because of Grant St. not moving. Mayor Barnes has stated he has sent INDOT a letter declaring Grant Street bridge reconstruction is a city priority. Mr. Gardner then stated that Frank DeRisi, district engineer for LaPorte District of INDOT, has stated verbally that Grant St. will be placed on the transportation projects list. With that happening, it will complete the line of protection on the north side. We are now awaiting an actual letter of commitment. An engineering schedule of the Corps and INDOT needs to be set.

Land Acquisition Committee - Land Acquisition Chairman Chuck Agnew made a motion for staff to have some repair work done on the wall at Gary Meat Market (hole will be left after they have a freezer removed) with cost not exceeding \$700; motion seconded by Nathaniel Leonard; motion passed unanimously.

Mr. Agnew stated that Mr. Gardner was going to be meeting with the Gary Park Board and staff, with I.U. Northwest Chancellor Hilda Richards.

<u>Project Engineering Committee</u> - Mr. Huffman stated that Stage III (from Chase St. to Grant St.) was almost complete. He referred to a letter from the Corps to Lake County Parks & Recreation asking them to review the Corps recreation plan for county parks and respond back. The recreation plans are a 50-50 cost share.

<u>Marina/Breakwater Committee</u> - Committee Chairman Bill Tanke announced that sandmining is still ongoing.

Mr. Tanke added that the NIPSCO lease is still being reviewed. The attorney is working with NIPSCO's attorney to work out a suitable agreement. NIPSCO has stated they will have the lease back to us by mid December. Staff will follow up.

Town Trustee Ted Ialeggio reported that the sand moving is about 2/3 complete. The original plan was to complete the sand moving and then bill the Commission. Mr. Ialeggio has said that the town has hired a smaller contractor who is requesting payment at 2 week intervals. Mr. Ialeggio presented the Commission with a second bill. Mr. Tanke made a motion to amend the agreement from one lump sum to a as-needed basis when presented with bills to be approved at the Commission meetings; motion seconded by Bob Huffman; motion passed unanimously.

Mr. Tanke then made a motion to add the second invoice of \$6,516 for sand transport to the claim sheet; motion seconded by Steve Davis; motion passed unanimously.

Mr. Tanke stated that we need to meet with Tom Largura of Superior to see exactly where we are on the sandmining and to see if we need to renegotiate a contract.

Mr. Tanke also announced that the permit for the marina project still is not approved by the Detroit Corps office. The permit application is not approved yet because the Detroit Corps is insisting on a 75' green belt area along the waterway which conflicts with the 250 marina slip requirement of the Chicago Corps. The two Corps offices need to come to some agreement and Mr. Tanke stated that if it is not resolved in the very near future, we will seek the assistance of the Congressman to write a letter.

Mr. Tanke made a motion authorizing Abonmarche to proceed with Task 7 for a cost not to exceed \$4,250; motion seconded by Steve Davis; motion passed unanimously.

Finance/Policy Committee - Treasurer John DeMeo presented the financial status report for November as well as the claims for approval. Mr. DeMeo made a motion to approve the pending claims; motion seconded by Robert Huffman; motion passed unanimously. Mr. DeMeo referred to the Corps letters requesting withdrawal of funds from the escrow accounts.

Mr. DeMeo stated a Finance committee meeting would be held before the next regular Commission meeting.

Mr. Gardner introduced Jon LaTurner of DNR, Div. of Water.

<u>Statements from the floor</u> - Dr. Buzz Lee thanked the Commission for its efforts in making possible the sand to the beach and paying for the transport of that sand and then paying the invoices as received.

Dominic Vasile from Wicker Park Manor subdivision stressed his disappointment that no levee work has begun. He felt that construction work should have been going on by now. Mr. Gardner answered that we would have liked to have seen work started this summer also. He offered Tom Deja's phone number to him. Mr. Deja is the Corps engineer in the local office.

Donald Shapiro asked why interlocks and sheet piling idea has been abandoned by the Corps. Mr. Gardner stated that the sheet piling along the ditch behind Tri State was only a temporary measure until levee construction was underway in that area. The sheetpiling is not in the overall Corps plan. Mr. Shapiro was concerned about the level of protection. Mr. Gardner answered in that the levee system is designed to withstand a 200 year flood level with a 3' overboard.

Mr. Gardner informed the audience that the next meeting would be held at the new office location in Portage at 6100 Southport Road.

There was no other business. The next Commission meeting will not be held on the first Thursday of the month. The next meeting was scheduled for Wednesday, January 12, 1994 at 6:30 p.m.

Levee construction to begin

Barring any future delays, the construction of a permanent levee for the Wicker Park Manor subdivision should begin this spring.

According to Dan Gardner, executive director of the Little Calumet River Basin Development Commission, it won't be long before crews are on the sight to clear and prepare the area for building.

But the actual construction process won't

get underway until winter passes.

"We had hoped to get more substantial construction done during the construction season, but unfortunately, that didn't happen...It's a slow process," said Gardner.

The Army Corps of Engineers is still

finishing up negotiations with the contractor, Dyer Construction Co., which was recently awarded a \$998,630 contract for the levee project.

Before Dyer Construction proceeds with its plans, letters explaining the construction procedure will be distributed to Wicker Park Manor property owners.

During the anticipated four to five month

construction period, workers will construct a new levee in a specified work area. The existing levee will not be removed until the improved protection is completed.

"The line of protection will be maintained at all times. No whole levee will be taken down until a full, new levee is constructed,"

said Gardner.

According to the contract, work will be done on weekdays, beginning no sooner than 7a.m. daily. The contractor reserves the right to work on Saturdays if necessary.

Dear Mr. Klika:

I am writing you regarding the design for the future Cline Avenue interchange reconstruction project relative to functional coordination with the design of the Little Calumet River Flood Control/Recreation Project. Several meetings have been held with INDOT officials, the U.S. Army Corps of Engineers, consulting engineers for the Town of Griffith (Lawson-Fisher Associates) and the Little Calumet River Basin Development Commission staff to coordinate the technical aspects of these projects. It has come to our attention through these meetings that the present INDOT design proposed for the road surface elevation of Cline Avenue south of the new interchange will only afford an approximately 20 year level of flood protection to the road. The Corps of Engineers project for the Little Calumet River is designed to provide a 200 year level of protection plus 3 feet of freeboard to the developed areas adjacent to the river and the Borman Expressway (I-80/94). Given the extremely flat topography of the basin area, an increase of elevation of only 2 feet will bring the road surface up to the 200 year level of protection. Given the significant financial investment INDOT is making in the Cline Avenue interchange reconstruction, and the significant investment the Federal, State and local governments are making in bringing flood protection to the Little Calumet River basin, it seems only wise to maximize the benefits of both projects.

We ask the INDOT policy and design officials to consider raising the design elevation of the Cline Avenue roadway by some 2 feet to bring the facility up to the level of flood protection of the Corps of Engineers project (200 year level of protection). We believe this change would afford significant benefits and assure maximum protection to INDOT's investment in the Cline Avenue project at a modest additional cost. The primary intent of the Little Calumet River Flood Control Project is to protect developed areas from flooding such developments as major transportation facilities, so we ask you consider changing your design elevations to best take advantage of the flood control design.

We stand ready to meet and discuss any questions you may have regarding this or related issues. Thank you in advance for your consideration and we look forward to hearing from you.

Dear Dan:

On behalf of the Town of Highland, I would like to thank you and the U.S. Army, Corps of Engineers, for the opportunity to meet with you and offer our comments relative to the Little Calumet River levee project. Everyone from the Town that was in attendance at the meeting expressed their appreciation and acknowledged the benefit of being informed about the project. Attached are letters from the various departments and Town Officials which express their comments and concerns.

My comments follow and are in the format as outlined in the "Issues for Consideration" distributed at the meeting and represent my understanding of the project and my concerns relative to the project.

1. Flood Protection

a. The levee will be of earthen design and construction with the exception of those sections adjacent to homes where space is critical. In these sections, flood walls will be constructed using sheet piling with a concrete cap.

b. The section of levee within the Town of Highland just west of Cline Avenue details an overflow section. As I understand, in the event of a flood or storm event greater than the design capacity of the levee, overflow of the levee would occur in predetermined areas along the river and reduce the catastrophic effect in populated areas. We are extremely concerned about this location for an overflow as there is no protection along the west flank of the spillway area. If this design is allowed, additional levee protection should be constructed along Liable Road, from the Little

Calumet River levee north to higher elevation. This "tie-back" levee would contain the floodwaters within the open space wetland area between Cline Avenue and Liable Road.

- c. Any relocation of the levee which brings it closer to homes may raise some concerns by adjoining property owners. Their reaction may relate to a perception that the flood waters will be closer to their homes and, consequently, they are in greater risk. Also, we understand that wetlands are important ecosystems; however, most residents near the river perceive them as mosquito breeding grounds. Please be prepared to justify these relocations if necessary.
- d. The Grace Street pumping station will be replaced. The 5th Street Stormwater Pump Station and 81st Street Stormwater Pumping Station will be refitted with new equipment. Equipment older than 20 years will be replaced. Equipment less than 20 years old will be reconditioned. Discharges through the levee will be equipped with two means of backflow protection. The Town requests consideration for emergency generating equipment to power all pump stations in the event of power failure. We are currently equipped with this level of protection at the 5th Street and 81st Street Stations.
- e. Construction routes to and from the site will be approved by the Town of Highland and included in the construction documents. Working hours (starting times) will be included in the construction documents.

2. Project Timing/Schedule

- a. The construction process will be phased to allow for the construction of the new levee first. Subsequently, the old levee will be removed or reshaped. This phasing will assure that there will be a continual level of protection equal to the current status.
- b. Projected construction is 1996 pending the committment of funds by the state.
- c. The town will be responsible for all utility relocations in conflict with the new levee.

3. Real Estate Issues

- a. The Little Calumet River Basin Development Commission will be obtaining both public and private lands necessary to construct the levee. This phase of the process has not yet been initiated in Highland.
- b. The project will include a hiking trail on the south levee entirely through Highland. The trail will be constructed of crushed gravel. In areas of flood wall construction, the trail will be on the land side of the

protection wall.

4. After Construction Landscaping

- a. A landscape expert has been engaged to create an appropriate landscaping plan that will serve to stabilize the levee slopes, be attractive, and be easily maintained.
- b. Maintenance responsibility of the levee subsequent to completion of the project has not been established. At present, the LCRBDC will be responsible, however, details as to how this will be accomplished are being worked out.

5. Process

a. Upon completion of the final plans and documents, local public and elected officials will have an opportunity to review the plans; subsequently, a public hearing or public review process will be included.

These are, generally, my comments and concerns on this project as I understand from the meeting November 3, 1993. If there are any misconceptions identified above or if you have any questions regarding this matter, please call me.



Little Calumet River Project

To summarize the concerns of the Parks & Recreation Department concerning this project:

- 1) The slope of the new levee system should be mowable with a riding mower. I believe most residents would like to see the area seeded with grass.
- 2) We did not discuss the "staging" or "access" areas that were designated in Homestead Park. I would hope that this will not hinder normal park usage.
- 3) As we have agreed previously, a recreational area will be developed jointly at 81st Street and Liable in conjunction with this project, and that 50% funding will be available for approved projects.
- 4) The issue of the INDOT new Indianapolis Boulevard Bridge and bridge that is being removed and its replacement might be best resolved by having the trail on the levee go under the new Indianapolis Boulevard Bridge. This would remove the need to replace the old bridge.
- 5) I have a concern about standing water in the areas behind the homes on Duluth Street by the Little Calumet. The new levee will be closer to these homes, and if water is allowed to stand may promote mosquito growth.

Dear Mr. Gardner:

As required by the Environmental Protection Agency (EPA) and the Indiana Department of Environmental Management (IDEM), this report summarizes the removal and disposal of four drums previously located at the subject property. Abonmarche Environmental Sciences, Inc. was retained by the Little Calumet River Basin Development Commission (LCRBDC) to coordinate the removal and disposal activities.

On 18 October 1993, four drums were removed from the City of Portage Marina site. The drums were transported by Abbott Transportation of Newburgh, Indiana to Somerset Refinery, Inc. located in Somerset, Kentucky. Three (3) drums contained petroleum sludge, sand, and rinse water resulting from the removal and cleaning of two (2) underground storage previously located at the subject property while the fourth drum contained an unknown petroleum substance (i.e., suspected to be hydraulic fluid). 



Task #7 - Engineering Services

Our previous request for authorization for Task #7 services dated, December 1, 1993, identified the need for \$2,500 in services for December, 1993. This request did not include budget for preparation of legal descriptions, easements, and survey drawings as requested by NIPSCO. As you know these drawings have been revised numerous times in December and January per NIPSCO's requirements, in addition to several meetings with them to receive approvals. We feel that as of January 7, 1994, we have verbally received these approvals for NIPSCO.

Accordingly, our cost for preparation of NIPSCO approval documents, in addition to Task #7 services for permit coordination/administration with the USCOE, sand contract, etc., budget is \$7,100 versus the \$2,500 originally per December 1 letter.

We hereby request your authorization to proceed with one-half of the cost of these services, and amend the December 1, 1993 budget accordingly. I would also suggest a budget of \$2,000 for January to allow for time to assist in approvals with the USCOE, NIPSCO, etc. Therefore the total request would be one-half of \$9,100 or \$4,550. AGREEMENT BETWEEN THE LITTLE CALUMET RIVER BASIN DEVELOPMENT COMMISSION AND THE

NORTHWESTERN INDIANA REGIONAL PLANNING COMMISSION FOR THE PROVISION OF GENERAL SERVICES

BY AGREEMENT MADE AND ENTERED INTO, on the date hereinafter written, by and between the NORTHWESTERN INDIANA REGIONAL PLANNING COMMISSION, hereinafter referred to as "NIRPC", and the Little Calumet River Basin Development Commission, hereinafter called the "LCRBDC", under the terms and conditions hereinafter set forth, the following is hereby agreed:

- A. NIRPC shall provide the LCRBDC services and assistance as is required by the LCRBDC to carry out its purposes under its enabling statute, IC S14-6-29.5 1 through 10, inclusive.
- B. NIRPC shall assign Daniel Gardner to serve part time (approximately 50% of total hours) in the capacity of Executive Director of the Little Calumet River Basin Development Commission and Sandra Mordus to serve full time in the capacity of Little Calumet River Basin Development Commission Operations Coordinator. NIRPC shall be compensated five thousand seven hundred and seventy-five dollars (\$5,775) per month for services provided by these two staff members. The amount is intended to cover both direct salary and fringe benefit costs. Should the need arise to replace either of these staff members during the course of the Agreement, it will be done with the mutual consent of both parties to this Agreement. Should either staff member receive a salary increase during the course of this agreement, the amount charged may be increased on a basis equivalent to the percentage salary increase.
- C. In conjunction with the above designated staff, NIRPC shall provide adequate office space and furnishing for their use and make available use of all common facilities within the overall NIRPC offices such as conference and meeting rooms, hallways, restrooms, etc.; the provision of basic utilities such as gas, electric and water; and the provision of reception services including the answering of telephones and greeting of visitors.
- D. In addition to the above designated staff and space, NIRPC shall provide the LCRBDC with two additional 10' by 10' offices for use by its employees or agents. For these two staff offices, the LCRBDC shall compensate NIRPC at the rate of five hundred dollars (\$500.00) per month.

- E. NIRPC shall set the salaries for those employees working primarily for the LCRBDC at levels recommended by the LCRBDC and agreed upon by the NIRPC Executive Director.
- F. The Executive Director of the LCRBDC will continue to function as Chief Staff Officer for the LCRBDC and be responsible for the operational and administrative functioning thereof including, but not limited to, the following:
 - Attendance at all regular and special meetings of the LCRBDC.
 - The conduct and coordination of negotiations for the Local Cooperation Agreement with the Army Corps of Engineers and all necessary State, County and local sub-Agreements to cause the construction and ensure funding of the flood control/recreation project and breakwater project.
 - The negation, coordination and/or preparation of all Federal, State and local legislative contracts, hearings and presentations relative to the LCRBDC business.
 - The presentation and negotiation with local municipalities, park boards, highway departments and sanitary boards relating to needed items of cooperation for the flood control, recreation and marina projects along the Little Calumet River.
- G. NIRPC shall provide the following financial management assistance to the LCRBDC and shall be compensated for such service by the LCRBDC at the rate of four hundred twenty-five dollars (\$425) per month.
 - 1. Aid the LCRBDC in preparation of its budget and provide accounting services for the receipt, investment and disbursal of its funds, all in accordance with applicable State Board of Accounts guidelines, statute, and guidelines set out by the Commission herein or otherwise.
 - Deposit LCRBDC funds in the name of the LCRBDC and in depositories designated the LCRBDC.
 - 3. Disburse LCRBDC funds only upon authorization to do so by the LCRBDC and presentation of a State Board of Accounts standard claim form signed by at least two Commission members and approved by the LCRBDC at a regular or special meeting. Checks shall be drawn from an account in the LCRBDC's name and shall be signed by the Treasurer and one other officer.

- 4. Provide monthly financial reports and line item financial accounting of budgeted expenditures.
- H. The LCRBDC shall be responsible for the cost associated with the installation and use of its own telephone lines. Such lines installed will be compatible with telephone equipment owned by NIRPC.
- I. NIRPC shall make available use of its postage machine. Actual postage cost shall be billed to the LCRBDC.
- J. NIRPC shall make available the use of its copy machine. Use of this equipment will be billed at the rate of \$5.00 per month plus \$.06 per copy.
- K. NIRPC shall make available use of its facsimile machine. Use of this equipment shall be billed at the rate of \$5.00 per month plus actual long distance phone charges.
- L. LCRBDC agrees not to install within the NIRPC offices telephone, copier, or facsimile equipment. Any furniture or other equipment installed shall be located within the spaces designated for the exclusive use of the LCRBDC.
- M. NIRPC shall make available the use of its graphics and printing equipment and personnel. Graphics and printing time charges will be billed at twenty dollars (\$20.00) per hour. No per copy charge will be made. No charge will be made for bond paper or miscellaneous printing supplies. However, special order items will be billed as material costs. Such items include, but are not limited to, metal plates, envelopes, binders, labels and other specialty items for printing and graphic work.
- N. NIRPC may make available additional space or other services to the LCRBDC on a direct request basis. NIRPC shall bill the LCRBDC for such services on a basis that is mutually agreed to by the parties.
- O. NIRPC shall provide itemized monthly billings for services performed. Payment shall be due within thirty (30) days after billing.

P. This agreement shall be effective January 1, 1994, and terminate December 31, 1994. However, either party may terminate the agreement at an earlier date by providing a written notice of intent at least 60 days prior to an effective termination date, which shall coincide with the last day of a calendar month.
