# MINUTES OF THE LITTLE CALUMET RIVER BASIN DEVELOPMENT COMMISSION HELD AT 6:30 P.M. WEDNESDAY, FEBRUARY 2, 1994 AT THE COMMISSION OFFICES 6100 SOUTHPORT ROAD PORTAGE, INDIANA

Chairman George Carlson called the meeting to order at 6:40 p.m. Six (6) Commissioners were present. Quorum was declared and guests were recognized.

The minutes of the January 12, 1994 meeting were approved by Chuck Agnew; seconded by Robert Huffman; motion passed unanimously.

Executive Director's Report - Mr. Gardner reported that some preliminary survey work has been done by Dyer Construction for the Wicker Park Manor levee project. The centerline of the levee was established.

The Commission has received an acknowledgement notice from DNR relative to the permit application filing for the removal of the abandoned Erie R.R. bridge. The application is in the process of approval.

Mr. Gardner reported the a meeting is scheduled for tomorrow with Gas City relative to the land needed for the levee project at Grant Street. The reconstruction of Grant St. bridge is estimated to happen in 1997. There is no written commitment or project schedule as yet.

Mr. Gardner also stated there was a verbal agreement by the Corps for a 40% minority participation in construction projects for the levee construction. A letter to that commitment is forthcoming but not received yet. The Corps was supposed to have met today to discuss the issue.

Land Acquisition Committee - Land Acquisition Chairman Chuck Agnew made a motion authorizing staff to proceed with condemnations for DC222, 232, 235, 247, 291, 293, 302, 303, 319, 320, 322, 326, 327, 328, and 333; motion seconded by Robert Huffman; motion passed unanimously.

<u>Project Engineering Committee</u> - Mr. Huffman stated that a meeting had been held relative to the flood warning system. Questionnaires were again distributed for the cities to fill out and return to us and the Corps.

He also reported that clearing and grubbing for the levee construction in Wicker Park Manor (Stage V) will probably not begin until May.

An on-site meeting was held in Griffith relative to a levee section being built by a private contractor. No decision has been made yet if the Commission will ask the Corps for a realignment of the federal levee in that particular area. Staff will pursue with the town of Griffith officials as to their position.

A meeting with WHITECO will be held February 9, 1994.

Mr. Huffman reported that the road closure materials are still being stored at the Lake County Civil Defense center. Staff is still hopeful in working out an agreement with Gary Civil Defense to store the materials in their headquarters instead.

Mr. Gardner introduced Ken Smith the IDNR who has been named as the DNR contact person who will be attending the Commission meetings. Mr. Smith came up early today to meet with the Corps to discuss the DNR permit process for the rest of the east reach and the upcoming west reach. Mr. Smith stressed the need to get the application in Staff will hire additional temporary help to get the application out.

Marina/Breakwater Committee - Committee Chairman Bill Tanke reported that we have received the Detroit Corps permit for the marina. The Detroit Corps and the Chicago Corps have reconciled differences and are in agreement for the required slip quota.

There is still no agreement finalized with NIPSCO. The Mayor of Portage will be meeting with NIPSCO and it is hoped that a satisfactory agreement can be reached.

Mr. Tanke made a motion to approve the two invoices received from Abonmarche. They were \$3,768,61 for additional services for Task 7 and \$901.88 for Task 4 & 10 (amounts are for 1/2 of total - other 1/2 to be billed to the city) contingent upon clarification by Ron Schults and approval by Committee Chairman, Executive Director and attorney; motion seconded by Chuck Agnew; motion passed unanimously.

Finance/Policy Committee - In Treasurer John DeMeo's absence, Mr. Gardner presented the financial status report for November as well as the claims for approval. Mr. Agnew made a motion to approve the pending claims; motion seconded by Robert Huffman; motion passed unanimously. Mr. Gardner stated that staff is working on an annual report.

Other Business - Attorney Casale reported that, at Bill Tanke's request from the last meeting, he has reviewed the Commission insurance and has found that the existing insurance coverage and amount is adequate; it covers both the liability on the Commission lands and insurance on the directors and officers of the Commission. The policies will be renewed upon their expiration dates.

Statements from the floor - Mike Vander Heyden stated to the Board that, in his opinion, if the Erie R.R. bridge was removed, the debris would just flow downstream to the Indpls. Blvd. bridge and catch there. Reconstruction of that bridge is hoped to begin in late 1994. Mr. Gardner stated that once the permit is in hand, we will assess the situation against the cost and see if it is a viable solution to remove it. Mr. Smith from DNR said that if the debris was discarded from property owners along the river, perhaps DNR could help. Mr. Gardner replied that most of the debris was trees and branches and felt there was no intentional discarding of debris into the river.

There was no other business. The next Commission meeting was scheduled for Thursday, March 3, 1994.

## **Erie bridge** slated for demolition

Steps are being taken to rid Highland of an abandoned railroad bridge which was one of the reasons for the tragic 1990 Wicker Park

Manor flood.

At the meeting of the Little Calumet River Basin Development Commission last Wednesday (Feb. 2), Executive Director Dan Gardner said the application for approval to demolish the Erie Railroad bridge in Highland has been received by the Indiana Departmen of Natural Resources (DNR)

acknowledgement came from the DNR on Jan 13 said Gardner. It is currently being

Approval from them can sometimes take up to six months. But we don't think the request is that detailed," said Gardner.

The bridge is about 300 feet west on the river from the Indianapolis Boulevard bridge. It is slated for demolition because over the years debris from the river has gathered at that bridge, causing the water to "swirl around and eat away at the levee" that is supposed to protect Wicker Park Manor from flooding,

This, Gardner said, was one of the reasons for the tragic Wicker Park Manor flooding in

At the meeting, Mike Vander Hayden, president of Dyer Construction, the company contracted to perform the levee work in Wicker Park Manor, voiced concern that you take that railroad bridge out, the debris will catch on the Indianapolis Boulevard

The Indianapolis Boulevard bridge only has 15-foot spans underneath it, said Vander Hayden. In a flooding incident caused by the debris, "it would take the whole bridge," he

Gardner, however, said that when the Army Corps of Engineers gets to the Indianapolis Boulevard bridge segment of the project in late 1994 or early 1995, a foot bridge would be put in at that location.

Much of this debris includes fallen trees

in the river, which costs between \$1,200 and \$1,500 to clear every time the area is cleaned, said Gardner. Many of these may come from two golf courses in the area, he said.

"We've asked the golf course managers to store debris in a way that it won't get into

the channel, he said.

Kenneth Hunt, a representative from the DNR who was present at the meeting, encouraged commission members to report storage sites along the river and Hart's Ditch where such debris may be stored.

We could look at that as a state violation,

and possibly give assistance, he said. In other business, Robert Huffman, chairman of the commissions Engineering and Construction Committee, said a meeting had been scheduled with Highland and Griffith officials to discuss the levee realignment along Cline Avenue where it crosses the river between them.

tt There's still some work going on with that. We hope to get with them later this

month," said Huffman

Also, Gardner said there still has been no response from residents of Wicker Park Manor's River Drive, who were mailed questionaires regarding the levee project a few months ago. Residents were asked to mail the completed questionaires back to the commission. Copies of the completed questionaires will be sent to the DNR, he said.

## Little Cal panel awaits minority contractor pact

PORTAGE – The Little Calumet River Basin Commission announced Wednesday that it is a few weeks away from receiving the Army Corps of Engineers' written agreement ensuring the flood control project has 40 percent minority participation.

This percentage would nearly double the existing federal minority participation regulations. The current level is 20.9 percent.

The \$110 million project that is de-

signed to improve flood control and recreation along the Little Calumet River extends from Martin Luther King Drive in Gary to the Illinois state line.

Commission Executive Director Dan Gardner said he has already received a verbal agreement from the project's commander Col. David Reed.

Gardner added that he expects to have a signed agreement by the commission's March 3 meeting.

The agreement will require that 40 percent of the contract money and 40 percent of the jobs go to minorities.

Gardner said the agreement should not have much affect on the project because the 40 percent levels of participation are already being met in most cases.

He added that the agreement also will preserve the project in case the Corps assigns a new project commander in the near future.

"The Corps changes commanders every 2 to 2-1/2 years, this July is Reed's second year," Gardner said.

In other business, the commission

announced it received a permit from the Corps to proceed with the construction of a 250-slip marina in Portage.

Gardner said the commission has worked nearly two years for the permit.

The marina will connect Lake Michigan and the Little Calumet

River near the Burns waterway just south of U.S. 12. Gardner said the estimated \$4.5 million project will take about a year to complete.

Gardner said excavation work to remove sand is currently underway at the site. He said the excavation should be finished in July, at which time construction on the marina can begin

## Little Cal panel advises state to revise plans for Cline interchar

PORTAGE - The Little Calumet River Basin Development Commission is advising that plans be revised for the Cline Avenue interchange construction project to provide for better flood protection.

Dan Gardner, the commission's execurive director, told members during Wednesday's meeting that he sent a letter to the Indiana Department of Transportation suggesting the change three weeks ago, and has yet to receive a reply.

Gardner said INDOT's current plan to

rebuild the ramps at Cline Avenue and at and flood control projects to be at the same Interstate 80.94 has a surface elevation level of protection. that provides 20-year-level flood protec "We believe this change would afford" that provides 20-year-level flood protec-

He said that by raising the road's surface level by 2 feet, flood protection would be increased to a 200-year level.

This designation means that the probability that flood waters will crest the level of protection is once every 200 years.

The Little Calumet River flood control-recreation project currently underway is being built to 200-year level of pro-

The commission wants the interchange

significant benefits and assure maximum protection to INDOT's investment in the Cline Avenue project at a modest additional cost," Gardner said in his let-

It seems to us as though that would be the wise thing to do," said Robert Huffman, a commission member. "It almost seems as an oversight on their part that they didn't put it at that level."

In other business, the commission agreed to meet with Highland officials and

the U.S. Army Corps of Engineers to discuss Highland's concerns about the flood control-recreation project.

Gardner said Highland officials want to explore building the flood levy in a differ-

ent area than the Corps has planned. He said Highland has proposed that the levy be built further south in an area to the immediate southwest of the Cline Avenue and I-80/94 intersection. Gardner said Highland would like to put the levy between a residential area and a wooded

Currently, the Corps is proposing to construct the levy between the river and the wooded area.

Gardner said Highland wants to explore whether the wooded area would provide additional protection for nearby homes in the event that flood waters exceed the 200year level.

The flood control-recreation project, which began earlier this year in Gary and is being worked westward to the Illinois boarder, is not scheduled to begin in Highland for another three years.

Gardner said the Highland phase of the project still is in the early planning stage, and this is the best time to discuss any

We have been in discussions with Mr. Ed Tang, Mr. Timothy Rogaczewski and Mr. Tom Caplinger on the design of the proposed reconstruction of the Cline Avenue (SR 912)/I-80 interchange, the US 41 Indianapolis Bridge over the Little Calumet River, and the culverts at Georgia Street and I-80 in Lake County, Indiana. first project will interface with our Little Calumet River, Indiana Flood Control and Recreation Project, currently in the design and construction stages. The other two projects are features of the flood control plan to be implemented by other than the Corps of Engineers and, as such, we need to have more direct coordination on their implementation than we have had to date. We have a few design considerations which we are requesting to be incorporated into your highway projects which can be funded by this agency; however, the procedure by which we could provide you with the funds cannot be executed to meet your schedule.

We are arranging with the Federal Highway Administration (FHWA) a procedure whereby we will provide funds through the FHWA to the Indiana Department of Transportation for the engineering and design and construction funds for certain flood control elements for inclusion in your projects. Your construction schedule is advancing faster than we are on the flood control features in this area. But by having you construct these features with the highway project, we will not need to revise your facilities at a later date. A copy of our arrangement with the FHWA is shown as enclosure 1.

Also enclosed are the project feature requirements and coordination and review activities we are requesting. The first, as shown in enclosure 2, is the activities on your SR 912/I-80 project. Enclosure 3 list the activities for the Indianapolis Blvd. bridge raise and enclosure 4 pertains to the Georgia Street and I-80 culvert replacements.

At this time we are only providing funding to develop an estimate of your consultant's costs to perform the engineering and design (E&D) for the flood control features we are requesting to be incorporated into your highway projects. After we agree upon a price, the remaining E&D funds will be provided. Funds for the construction will be provided through FHWA after the designs have been approved by Chicago District.

In the discussions on the SR 912/I-80 project, the Little Calumet River Basin Development Commission requested a realignment of our levee system that ties into SR 912 to go around the existing wetlands to the west. We are investigating this proposal and, if accepted, the south approach of SR 912 would no longer be our line of protection and we would not request the roadway to be raised as we previously discussed with Mr. Tang.

## CLINE AVENUE (SR 912)/I-80 INTERCHANGE RECONSTRUCTION

PROJECT: Reconstruction by the Indiana Department of Transportation (INDOT) of the Cline Avenue (SR 912)/I-80 interchange with funds also being provided by the Federal Highway Administration.

## CORPS OF ENGINEERS' (COE) FEATURES:

- A. Provide a seal embankment along the NE access ramp to function as the line of protection for the Little Calumet River, Indiana Flood Control and Recreation Project on the north bank from Cline Avenue east to the E.J. & E. Railroad. Figure 1 shows a layout of the approximate location of the seal embankment. Figure 2 shows a cross section of how the seal would be placed along the highway embankment.
- B. Provide a gate well with closure structure on all storm water drains, 36 inch in diameter or greater, that discharge through the flood control project line of protection. These gates wells will be designed in accordance with COE Engineering Manual (EM) 1110-2-290 and the Chicago District ED-D "Pump Station Discharge Pipes Under Levee and Gate Well Structures."

#### COORDINATION ACTIVITIES

- A. The engineering and design of the Corps of Engineers' features listed above shall be performed by INDOT or their contractors in accordance with COE criteria and specifications.. The plans and specifications will be reviewed and approved by the COE before incorporation into any construction contract.
- B. The construction of these features will be by INDOT contracted forces. These features will be shown as a separate bid item and shall be built in accordance to COE specifications. The COE will exercise periodic construction management review.

### INDIANAPOLIS BLVD. BRIDGE RELOCATION

PROJECT: The Little Calumet River, Indiana Flood Control and Recreation Project includes raising the existing Indianapolis Blvd. (US Route 41) bridge in lieu of having closure structures at the line of protection in order to maintain continuous traffic flow during flood events. The Local Cooperation Agreement specifies that the responsibility of the bridge relocation to be the Little Calumet River Basin Development Commission, as the Local Sponsor. The actual relocation is being undertaken by the Indiana Department of Transportation (INDOT), owner of the bridge, with funds also being provided by the Federal Highway Administration.

### . CORPS OF ENGINEERS' (COE) FEATURES:

- A. Provide the line of protection through the approach embankments by funding the cost of the embankment material corresponding to the cross section of the adjoining levee embankments. Figure 3 shows the required fill as part of the roadway that would act as a line of protection. This should be placed on the north approach in an alignment with our proposed levees as shown in figures 4 and 5 and on the south approach in the alignment as shown in attached Wicker Park Plans
- B. Provide a gate well with closure structure on all storm water drains, 36 inch in diameter or larger, that discharge through the flood control line of protection.

#### COORDINATION ACTIVITIES

- A. The engineering and design of the Corps of Engineers' features listed above shall be performed by INDOT or their contractors in accordance with COE criteria and specifications. The plans and specifications will be reviewed and approved by the COE before incorporation into any construction contract.
- B. The construction of these features will be by INDOT contracted forces. These features will be shown as a separate Bid Item and shall be built in accordance to COE specifications. The COE will exercise periodic construction management review.

## REPLACEMENT OF LITTLE CALUMET RIVER CULVERTS UNDER GEORGIA STREET AND I-80

PROJECT: The little Calumet River, Indiana Flood Control and Recreation Project includes increasing the flowage capacity of the culverts under Georgia Street and I-80. The Local Cooperation Agreement specifies that the responsibility of the culvert relocations to be the Little Calumet River Basin Development Commission, as the Local Sponsor. The actual relocation is being undertaken by the Indiana Department of Transportation (INDOT), owner of the transportation facility, with funds also being provided by the Federal Highway Administration.

## CORPS OF ENGINEERS' (COE) FEATURES

Include the implementation of the culverts relocations in all NEPA and other environmental and permitting documents required for the Little Calumet River, Indiana Flood Control and Recreation Project that are the responsibility of the COE and the Local Sponsor, to include:

(1) Filing of a Environmental Assessment,

(2) Obtaining a Section 401 Water Quality Certification from the Indiana Department of Environmental Management,

(3) Filing a Rule 5 General Permit letter with the Indiana Department of Environmental Management in accordance with the National Pollutant Discharge Elimination System Program,

(4) Including this activity in the Floodway Construction Permit for the remaining Eastern Reach of the Project to be obtained by the Local Sponsor from the Indiana Department of Natural Resources.

#### COORDINATION ACTIVITIES

- A. The engineering and design, plans and specifications will be reviewed by the COE before award of any construction contract.
- B. The construction will be by INDOT contracted forces. The COE will exercise periodic construction management review.

The purpose of the investigation was to determine the soil bearing capacity for buildings and the soil properties for the design of the steel sheet pile retaining walls.

At present we understand that the marina will include one story wooden framed or masonry block office/restroom structures. The retaining walls will be steel sheet piling around the perimeter of the marina basin, and timber, concrete, masonry, or steel sheet piling retaining walls as needed throughout the project where steep slopes exist.

Our investigation consisted of analyzing the logs of four soil borings made by K & S Testing of Highland, Indiana. The borings consisted of two (2) 30 foot deep, one (1) 40' deep, and one (1) 75 foot deep bore hole. The boring logs and a boring location map are detailed in Appendix A of this report.

The borings revealed that the soils on-site generally consist of medium dense to dense fine sand and silty sand underlain by dense to very dense find sand and silty sand. Some organic silt was encountered in Boring B-4 an elevation of 556' to 562' (surface elevation of 585'). Some very stiff silt and silty clay was encountered in Boring B-1 at an elevation of 517' to 523' (surface elevation of 584'). While the soils are generally consistent throughout the site, the soil profile appears to vary from the west to east side of the site. Most noticeable is the depth to the underlying dense to very dense sand layer, which is located at approximate elevation 579' on the west side, and approximate elevation 573' on the east side of the site.

Based upon the available information and our understanding of the project, we anticipate that the site is suitable for marina development. The office/restrooms structures may be supported on strip or isolated footings, and may load the soil to 2500 pounds per square foot, limiting total

settlement to one half (1/2) inch. The footings should be placed on undisturbed soil or soil compacted to 98% maximum dry density. Soil design properties for the marina basin steel sheet piling walls will vary from the east to west side of the site, as described earlier, and are summarized below:

Other retaining walls should be designed for an equivalent fluid weight of 39 pounds per cubic foot.

The scope of this report does not include any environmental assessment or investigation for the presence of wetlands or hazardous or toxic materials in the soil, surface water, groundwater, on, below or around this site. The scope is limited to the evaluation of the subsurface soil conditions for the support of building foundations, design of retaining walls, and other related aspects of site development.

The recommendations in this report are based on the project development as we currently understand it. Should there by any changes in the development plans or potential building designs, a re-evaluation of the data may be required.
