MINUTES OF THE LITTLE CALUMET RIVER BASIN DEVELOPMENT COMMISSION HELD AT 6:00 P.M. THURSDAY, DECEMBER 6, 2001 6100 SOUTHPORT ROAD PORTAGE, INDIANA

Chairman William Tanke called the meeting to order at 6:05 p.m. Seven (7) Commissioners were present. Pledge of Allegiance was recited. Quorum was declared and guests were recognized.

Commissioner Bob Huffman made a motion to approve the minutes of November 1, 2001; motion seconded by Emerson DeLaney; motion passed unanimously.

Chairman's Report — Chairman Tanke reported on the NAFSMA conference in Charlotte, NC that he and Dan Gardner attended. He stated that a main speaker was Brig. Gen. Griffin, Director of Civil Works for the Army Corps of Engineers in Washington. Other speakers included Michael Parker, Asst. Secretary of Army for Civil Works; Michael Cook, Director of Wastewater Management at the USEPA; John Studt, Chief of Regulatory Branch, Civil Works, Corps of Engineers; John Anderson, House Water Resources & Environmental Subcommittee, Washington; Charles Hess, Headquarters, Corps of Engineers; and others. He felt it was a very good conference. Mr. Gardner agreed and distributed a handout addressing Stormwater planning and training. Commissioner Reshkin inquired whether this Commission has any stormwater and wastewater responsibility. Discussion ensued.

Executive Director's Report - Executive Director Dan Gardner informed the Board members that he will meet with Ron Trigg of Shirley Heinze Environmental Fund and their attorney and COE officials on December 12th to discuss the 3rd party agreement. He views this meeting as kind of negotiating session to first establish their interest in being the 3rd party and then working out the language in the agreement that would be acceptable to all parties. Discussion was held. Mr. Gardner then distributed the letter that the COE wrote to Mayor Scott King in response to his letter of November 10th addressing the mitigation lands within the city and Hobart Marsh.

Mr. Gardner spoke on the public meeting that was held for Stage VIII. There were a little over 100 people in attendance. It was a good opportunity to present that portion of the project to the affected residents, and we were also able to make contact with several town officials and discussed setting up a presentation to their fellow council members. We also discussed future funding of the project and how the residents could help us by contacting their area legislators in support of the project. It was a very good positive presentation and overall, was very well received by the residents. We will continue to have more meetings as we get closer to construction in the west reach. Jim Pokrajac displayed maps showing the real estate and construction impacts relative to residents' property lines; Judy Vamos showed the project video; the COE had a power point presentation, there was a question and answer period; and the A/E was available for questions also.

Mr. Gardner stated that he, as well as attorney Lou Casale and Chairman Bill Tanke, met at the Chicago District COE office on November 13th. As the outcome of that meeting, staff from the Congressman's Office requested that the Board adopt a statement prioritizing the remaining state budget appropriation. Mr. Gardner distributed a priority sheet listing out 4 priorities. Commissioner Vosti made a motion to adopt this priority statement; motion seconded by Steve Davis; motion passed unanimously. (that priority statement is attached herein as Attachment 1 and made part of these minutes)

<u>Land Acquisition/Management Committee</u> – In Committee Chairperson Arlene Colvin's absence, Curt Vosti gave the committee report. He reported that there are no increased offers or condemnations this month

Discussion was already held on the Stage VIII public meeting that was held.

Mr. Vosti reported that staff has prepared a 1st draft of the Operation and Maintenance Summary Chart for the Gary segments along the river. It appears to be very thorough and staff is currently gathering additional information for costs, frequencies, and other details.

The attorney is researching information on the 75' drainage easement the Commission has along the river and has researched a new case that may give us strength to enforce the law as it reads.

<u>Project Engineering Committee</u> – Committee Chairman Bob Huffman gave the engineering report. He reported that the committee had a meeting on November 13th in which a number of engineering cost saving items were presented that Jim Pokrajac and Jim Flora had developed. Staff then submitted those cost saving items to the COE on December 6th to familiarize themselves with our suggestions.

A proposal from R. W. Armstrong Company for design services of the Kennedy Ave. pedestrian walkway onto the existing bridge was received at a cost of \$26,000. After discussion, the proposal was tabled until such time that final engineering review considerations would be needed to implement into their final plans.

Mr. Huffman reported that staff has completed final engineering review for Stage III remediation and they are now doing final engineering review for Stage VI Phase 2. This is scheduled for bid in January 2002 and contract award in April 2002.

Mr. Huffman also stated that the COE has requested we do pipeline locations and elevations in Stage V Phase 2 that could cost the Commission up to \$40,000. It was discussed that the COE should do this as part of their engineering services that include utility coordination.

<u>Legislative Committee</u> – Committee Chairman George Carlson gave the legislative report. He reported that the House Ways & Means had a field hearing discussing the Governor's tax restructuring proposal.

The hearing's purpose was to hear an explanation on the part of government officials from Indianapolis to identify financial problems of the State and how they can be dealt with.

Mr. Carlson added that attended the public hearing on Stage VIII and complimented Mr. Gardner and the staff on an excellent presentation.

<u>Recreational Development Committee</u> – Committee Chairman Curt Vosti gave the Recreation Report. There is no activity in recreation at this time. Additional recreational trail work will resume with the next contract.

A proposal for a recreational pedestrian walkway onto the Kennedy Avenue bridge was discussed. R. W. Armstrong submitted a quote to Engineering for \$26,000. We will forward our feasibility study to the COE.

<u>Marina Committee</u> – Committee Chairman Bill Tanke stated that a meeting has not been scheduled yet with the city. There is no further information.

<u>Finance/Policy Committee</u> – Treasurer Curt Vosti gave the Finance report. He reported that a Finance Committee meeting had been held on November 15th to review year end financial status and approve compensation changes to present to the Board for their approval. Mr. Vosti referred to the letter from him with supporting documentation that was included in the agenda packet.

Mr. Vosti presented the committee's proposed changes. They were: (1) Adoption of the Operating Budget for 2002. The budget holds the Administration Budget to the same level as 2001; the Land Acquisition Budget assumes the release of the \$2.5 million from the Budget; (2) Recommendation to dedicate the interest on the COE escrow accounts in the amount of \$118,677.82 to the Administrative Budget; (3) adoption of changes made to existing services contracts that include NIRPC contract for administrative services for the year 2002, a compensation adjustment to Dan Gardner in the amount of \$5,500 and an amount of \$4,000 to Sandy Mordus (the same amounts as last year), an hourly increase of \$4.75 to contract employee Jim Pokrajac (total compensation would be \$50.75/hour), an hourly increase of \$3.50 to contract employee Judith Vamos (total compensation would be \$36.50/hour), an hourly increase of \$1.75 to contract employee Lorraine Kray (total compensation would be \$18.25/hour); and legal services contract would be increased for \$85 to \$90 per hour. Mr. Vosti proceeded to make a motion approving the above-mentioned changes; motion seconded by George Carlson; motion passed unanimously. In regards to the proposed increase in hourly for R. W. Armstrong, it would have to be considered as a separate item because it was not before the Finance Committee at their meeting. Mr. Vosti proceeded to make a motion approving an increase from \$135 to \$150/hour for consulting engineer Jim Flora of R. W. Armstrong Company with the new contract beginning December 15, 2001; motion seconded by Bob Huffman; motion passed unanimously. Mr. Gardner assured the Board members that there are sufficient funds available in the budgets to meet these increases. There was also discussion that a proposal may be forthcoming addressing paralegal fees that is billed to us as part of the legal services contract from the attorney. It will be addressed at the next meeting. Staff was asked to develop a work scope for duties performed by Lorraine Kray. At present, there is no work scope.

Mr. Vosti presented the claims for November in the amount of \$63,051.82; motion seconded by George Carlson; motion passed unanimously.

Mr. Vosti then mentioned that travel policy information was also distributed to Board members in their packet. The committee will be meeting after the holidays to further discuss this issue and action will be taken at a later date.

<u>Minority Contracting Committee</u> – In Committee Chairman Marion Williams' absence, Jim Pokrajac stated that all construction in the east reach is complete and we have received monthly minority participation reports on all the contracts. The only ongoing projects are for the pump stations in the west reach.

Other Business - Chairman Bill Tanke announced the receipt of a letter from the Governor naming Robert Marszalek, superintendent of River Forest School, to fill the remaining term of deceased member Charles Agnew's term, which expires December 31, 2003. Mr. Marszalek apologizes that he could not make this evening's meeting; he already had a commitment made when he received the appointing letter from the Governor's office.

Mr. Tanke stated that the Nominating Committee, consisting of Emerson Delaney (chairman), Arlene Colvin and Steve Davis, will have a report at the next meeting.

<u>Statements to the Board</u> - Sandy O'Brien, Hobart, complimented the Commission on the openness on which it conducts its business.

Jim Piekarczyk, Sierra Club/Munster, inquired about the final phase of the levee project. Jim Pokrajac stated that some areas in Stage VIII (Stateline to Columbia) will have an I-wall 1-1/2' to 3' above existing ground level. Concern was on increased development in this area and that the hydrology in this area was based on maps that are outdated. The length of time that it is taking us to construct will push the end completion date even further away. Commissioner Vosti agreed that it is a concern but we are constrained by funding.

Sandy O'Brien expressed a concern that the Commission would want to re-do the mitigation plan. Mr. Gardner assured her that we are not considering that at all. Imad Samara added that the COE has an approved plan and they have no intention of re-doing it either. She expressed a concern that the lands in Hobart Marsh would be bought up by others and not be available for mitigation lands and we should consider other entities to purchase the lands and hold them for us, i.e. Trust for Public Lands. Mr. Gardner replied that our first obligation is to work with Shirley Heinze Environmental.

Don Ewolt, Lake Erie Land Co., inquired whether there was a sewer ban on in the Hobart Marsh area. If that is the case, no development could take place until it was lifted.

The next meeting was scheduled for Thursday, January 3 at 6:00 p.m.

ADOPTED PRIORITIES FOR USE OF REMAINING STATE BUDGET APPROPRIATION - 2001-03

- 1. Purchase of maximum number of properties in the west reach of the project area to put ourselves in the best position to let new Federal flood control construction contracts at the earliest date possible. Concentration will be on Stage VI Phase 1 and Stage VI Phase 2 working westward from Cline Avenue. All properties will be fully creditable.
- 2. Pursue west reach permit for construction in a floodway issued by the Indiana Department Natural Resources. This permit necessitates the approval and beginning implementation of a required wetland mitigation plan. Concentration of efforts on letting in-project mitigation contract and utilizing State appropriations to purchase necessary off-corridor mitigation lands identified in the Hobart Marsh area. Work with the IN Department Natural Resources and Shirley Heinze Environmental Fund toward the dedication of their properties for mitigation commitment with minimized cost. Property acquisition will be targeted to fully creditable items.
- 3. Continue discussion with the Gary city administration and other local leaders to identify local financial resources for the non-Federal portion of the Burr Street betterment levee construction. This acquisition and cost sharing is currently not creditable. Closely monitor progress because if funding source cannot be identified prior to potential west reach construction the gap in the line of protection at the Burr Street area will prohibit west reach construction initiation. Continue working with the city administration to explore timely fund commitment.
- 4. Complete east reach remaining parcel acquisition. This activity is fully creditable.

- 1. We had a pre-construction meeting with the Lake County Highway Department on January 3, 2002 to review their Hohman Avenue bridge project.
- 2. We received correspondence from the Lake County Surveyor's Office on December 21, 2001 regarding Hartsdale Pond status.
 - Pumps and spillway should be completed no later than March, 2002 and at that point, the pond will be pumped down.
 - We have been made aware that the "Doughman borrow site" should have approximately 600,000 additional yards of clay available to the project, which should eliminate the need for all future project clay needs (p. 23-24 Engineering Report)
 - We wrote a letter to the COE on December 12, 2001 requesting we remove the Clark-Chase borrow site (p. 22 Engineering Report)
- 3. We submitted a letter (along with all enclosures) to the COE on December 6, 2001 for their review. Upon their response, we will have a meeting to discuss the feasibility of these issues. Then LCRBDC will do an economic justification analysis.
- 4. We received correspondence from INDOT consultant, Hanson Professional Services, Inc., on December 13, 2001 regarding their upcoming construction for I-80/94, and requesting our comments or concerns.
 - · Copies are available upon request
- 5. Completed review of Stage VI-2 engineering plans & specs (Liable to Cline, south of the river) and found the COE's 100% set to be incomplete for review.

LAND ACQUISITION REPORT For meeting on Thursday, January 3, 2002

(Information in this report is from November 28, 2001 – December 26, 2001)

STATUS (Stage II Phase I) - Harrison to Broadway - North Levee:

1. Project completed July 10, 1992.

STATUS (Stage II Phase II) - Grant to Harrison - North Levee:

1. Project completed December 1, 1993

STATUS (Stage II, Phase 3A (8A) - Georgia to Martin Luther King - South Levee:

1. Project completed January 13, 1995.

STATUS (Stage II, Phase 4) - Broadway to MLK Drive - North Levee:

1. Project completed September 15, 1998.

STATUS (Stage II, Phase 3B) - Harrison to Georgia - South Levee:

- 1. Project currently 98% complete.
- Additional land will be required to temporarily extend a recreation trail along both the sidewalks east and west of Broadway to allow recreation trail continuation. (Refer to Recreation Report.)
 - Upon completion of I.U. Northwest modifications on, and adjacent to, Broadway, we will
 install a permanent trail crossing south of the river and along the line of flood protection,
 as originally proposed by the COE.

STATUS (Stage II, Phase 3C2) - Grant to Harrison:

- 1. Completion and turnover of O&M manuals was done on November 21, 2000.
- 2. The re-location of the recreation trail would require agreements with the city of Gary to be able to cross Grant St. at the light at 32nd Ave.
 - We will be receiving a letter from the COE requesting that we postpone Broadway and Grant Street recreation trail re-locations, and that they be included in the next recreation contract. (See Recreation Report.)
 - A meeting was held on April 12, 2001, to review our proposals for trails at Broadway & East of Grant. (See Recreation Report)
 - We received a response from the city of Gary on July 11 (From Roland Elvambuena, City Engineer) indicating their concurrence to our proposed re-location. (Refer to Recreation Report).

STATUS (Stage III) - Chase to Grant:

- 1. Levee construction completed on May 6, 1994.
- 2. Final acquisitions for flowage easements east of Chase and north of the river are ongoing (DC209 to DC213). Appraisals are being reviewed by COE.

STATUS (Stage IV - Phase 1-North) - Cline to Burr (North of the Norfolk Southern RR):

1. Construction is complete. Final inspection was held on August 30th, 2001, with minor turnover items & "as-built" drawings due to the LCRBDC.

STATUS (Stage IV - Phase 1-South) - Cline to Burr (South of the Norfolk Southern RR):

1. Bids were reviewed and <u>Dyer Construction</u> is the contractor. Work started on May 23rd, 2000 – 450 days to complete project . Project currently 85% complete.

STATUS (Stage IV - Phase 2A) - Lake Etta - Burr to Clark:

1. Construction is complete.

STATUS (Stage IV - Phase 2B) - Clark to Chase:

1. Construction is complete.

STATUS (Stage V - Phase 1) - Wicker Park Manor:

1. Project completed September 14, 1995

STATUS (Stage V - Phase 2) - Indianapolis to Kennedy - North Levee:

- Wicker Park appraiser John Snell has received the hydrology information from the COE. Appraisal will be completed by mid-December.
- 2. North Township owns the property west of Hart Ditch to Hawthorne Street. North Township has mentioned a possible relocation of the levee onto this parcel.
 - Meeting was held on 7/19/01 with COE, Munster, and North Township trustee Greg Cvitkovich. COE is reluctant to relocate the levee due to re-design costs.

STATUS (Stage V - Phase 3) - Northcote to Indianapolis - (Woodmar Country Club):

1. Woodmar preliminary figures are in from appraiser Dale Kleszynski. Since Woodmar Construction is 2-3 years in the future, Woodmar acquisition is not a priority.

STATUS (Stage VI-Phase 1) - Cline to Kennedy - North of the river, and Kennedy to Liable - South of the River:

- 1. The COE advises that no significant changes can be made to the majority of the Kennedy Industrial Park acquisitions. The three hotels only could be slightly modified.
 - Cost saving issues were discussed at the November 13th, 2001 Engineering Committee meeting.
- 2. We sent a letter along with information to the COE on December 6th, 2001, requesting their review of our proposals for cost savings issues. This could impact all real estate in this area. (Refer to General Comments in Engineering Report)
- 3. A letter was sent to Krosan Enterprises on November 28th, 2001, requesting information on how much area they need for traffic flow South of their building. (Refer to Stage VI-1 in Engineering Report.)
- 4. Dale Kleszynski, appraiser of Kennedy Industrial Park, met with LCRBDC on December 26th, 2001. He was informed of the 75' easement and thinks that acquisition costs will be considerably reduced by using the easement figures.

STATUS (Stage VI - Phase 2) Liable to Cline - South of the River:

- 1. We had a recreation coordination meeting with Highland and Griffith to determine trail relocation which allow us to cross at Cline Avenue at Highway Avenue. (Refer to Recreation Report)
 - A field meeting was held with Griffith on June 27th, 2001, to review possible routes East
 of Cline. Information will be provided to the COE to review and implement.

STATUS (Stage VII) - Northcote to Columbia:

- LCRBDC has reviewed and submitted real estate drawings to the COE. Waiting for response.
- 2. A public meeting for affected landowners has been scheduled for Wednesday, January 30th, 2002, 6:30 pm at the Wicker Park Social Center in Highland.

STATUS (Stage VIII - Columbia to State Line (Both Sides of River)

1. A public meeting was held November 28th, 2001, at Wicker Park Social Center for landowners and those adjacent owners affected by the project. **The meeting complies with the Federal Regulation.**

STATUS (Betterment Levee – Phase 1) E.J. & E. Railroad to, and including, Colfax North of the NIPSCO R/W – Ditch is South of NIPSCO R/W from Arbogast to Colfax.

1. Construction has been completed and the final inspection was held on August 30th, 2001. Minor turnover items and "as-built" drawings are due to the LCRBDC.

STATUS (Betterment Levee – Phase 2) Colfax to Burr Street, then North N.S. RR, then East (North of RR R/2) ½ between Burr and Clark, back over the RR, then South approx. 1,400 feet:

- 1. Acquisition deadline of October 2001 has been extended to summer of 2002.
- 2. Appraisal addendums for two corporate landowners Mansard Apartments and I-80/94 Auto Parts are complete. Offers, however, will not be sent because Burr Street levee costs are not creditable.

EAST REACH REMEDIATION AREA - (NORTH OF I-80/94, MLK TO I-65):

 LCRBDC sent a letter to attorney on 10/16/01 to begin acquisition of properties on the tax sale. Attorney sent letter to Lake County Commissioners on 11/29/01 requesting 10 properties.

MITIGATION

1. A meeting was held on December 12th, 2001, with representatives of the DNR, Shirley Heinze Foundation, National Lakeshore, COE and LCRBDC to discuss Hobart Marsh. National Lakeshore is willing to work with LCRBDC. Shirley Heinze Group will get back to LCRBDC on whether their initial 200 + properties will be a donation or require some kind of payment.

Coughenour: 'I have a deep respect for what the Corps does'


The Public Affairs Office had a chance to sit down with Ray Coughenour, the new deputy district engineer. Here's what Ray had to say:

I accepted this job because I have a deep respect for what the Corps does for the country both from a military and civilian side. I have a unique management style that is a combination of hands-on hands-off. I believe that every person in the district is qualified to do their job and do it well. I want to use my management skills to help enhance the great performance that is already here.

I have over 27 years total service in the military, including service in the Active Army and Army Reserve as a Corps of Engineer Officer. Retired status as a lieutenant colonel. Various assignments as a company commander of a Combat Engineer Company, battalion executive officer of a Combat Engineer Battalion and battalion commander of a Training Support Battalion, which was one of the first combined Active Army /Army Reserve / National Guard units in the entire Army. Overseas service included duty in Korea, Central Europe, Bosnia, Croatia, Central America.

Prior to coming here, I was the district business officer for District A of the Los Angeles Unified School District. My duties were the overall management of all non-instructional functions for 70 school facilities with over 70,000 students, with a 250 million dollar annual operating budget. RECREATION REPORT

For meeting on Thursday, January 3, 2002

(Information in this report is from November 28, 2001 - December 26, 2001)

GENERAL STATEMENT:

- A. At this point in time, the existing construction contracts in the East Reach are almost all completed. The only remaining area of construction is the Betterment Levee Phase II. No recreational trail work will resume until the next contract is awarded.
- B. Currently, the joint recreation venture with the Army Corps is completed; 90% of the completed east reach levees have stoned trails completed; the remainder of east reach trails are currently being coordinated and should be included in an upcoming recreation contract. The Corps will write us a letter requesting a change in this scheduling. (Still awaiting letter as of November 27th, 2001.)
 - It is anticipated that the next recreation contract may be in 2003-2004, and that the
 construction and real estate costs for this work would be delayed until that contract is
 ready to let.
 - A supplemental contract will be released as part of the Stage III remediation project in the late summer of 2001 that will include the paving of all ramps.

RECREATION - PHASE 1.

(This contract included recreational facilities for Lake Etta, Gleason Park, Stage III (trails), and the OxBow area in Hammond.

A. OXBOW (Hammond)

 October 28th, 1998 was the date that this facility was turned over to the City of Hammond.

B. GLEASON PARK (Gary Parks & Recreation)

1. October 28th, 1998 was the date this facility was turned over to the Gary Parks and Recreation Department.

C. LAKE ETTA (Lake County Parks)

1. October 27th, 1998 was the date that this facility was turned over to the Lake County parks department.

D. CHASE STREET TRAIL (City of Gary)

1. October 27th, 1998 was the date that this facility was turned over to the City of Gary.

EAST REACH RECREATION

A. Recreation trail re-alignments will be required in the east reach due to conflicting land use plans with City of Gary, I.U. Northwest, or other regulatory groups. (Refer to general statement.)

1. <u>Broadway to Harrison Crossing:</u> (Currently on hold until the next recreation contract.)

- We received a letter of response from INDOT on October 18 indicating no concerns regarding the crossing at Broadway as long as we coordinate with the locals, and that a right-of-way permit with them would be required.
- We will be making application with the City of Gary to use the Broadway r/w (the existing sidewalks) on both sides to go South to 33rd Avenue to cross at the light.
- Upon completion of I.U. Northwest modifications on, and adjacent to, Broadway, we will install a permanent trail crossing south of the river and along the line of flood protection as originally proposed, and the temporary trails on the sidewalks on the Broadway right of way will be abandoned.

2. <u>Harrison to Grant Street Crossing:</u> (Currently on hold until the next recreation contract.)

- We received a letter from the City of Gary on July 11th, 2001, indicating that our proposal East of Gilroy Stadium to 32nd Avenue is the best use location from Harrison to Grant.
- 3. We submitted a request to Attorney Casale on August 3rd, along with a letter from the EJ&E RR to proceed with an agreement to allow us to install an at-grade recreation trail crossing East of Cline Avenue.
 - We received a letter from the EJ & E on September 1st, 1999, allowing us to proceed along with their requirements. (To Lou at September 10th, 2001 utility coordination meeting.)
 - The scope of this work will be done as part of the Burr Street Phase 2 project instead of Stage VI-2.

WEST REACH RECREATION

A. Cline Avenue Crossing:

- 1. We had recreation coordination meetings with Highland and Griffith to determine trail relocations which allow us to cross at Cline Avenue at Highway Avenue
 - A field meeting was held with Griffith on June 27th, 2001 to walk and review potential recreational trail adjustments east of Cline.
 - A meeting was held with Highland on July 5th, 2001, to review the recreation trail location west of Cline Ave. A follow-up meeting was held with the Cline Avenue Baptist Church on July 16th, 2001, to review the possibility of getting an easement across their property adjacent to Cline Ave.
- 2. A letter was sent to the COE on July 23rd, 2001 along with sketches showing the proposals and suggesting a meeting to review and discuss these locations.

B. <u>Tri-State recreational trail tie-in for the Highland/Wicker Park/Erie Lackawanna Trail Systems:</u> (Part of Stage V – Phase 2 construction.)

- 1. The COE modified the engineering and real estate drawings and submitted them to us at the Real Estate meeting on July 19th, 2001. It is still the intent to have this recreation trail on the land side. (Refer to Land Acquisition & Engineering Reports).
- 2. North Township Wicker Park recreational trail alignment is being evaluated.
 - It was mentioned to re-locate the trail from between the golf courses to the existing trail along the West and South boundaries.
 - North Township would not have a problem, but are awaiting information from INDOT for impacts to Indianapolis Blvd. R/W which would cause their existing trail to be re-located. (Ongoing)
 - We had a meeting with Highland to discuss Highland/INDOT plans for drainage in this area (See Engineering Report).
- C. A letter was sent to the Lake County Highway Dept. on December 28, 2000 requesting permission, and comments, to cantilever a walkway on the east side of the Kennedy Avenue bridge to allow our trail to be contiguous.
 - 1. It was approved at our February 1st, 2001 Board meeting to contract with R.W. Armstrong to do a feasibility study for the pedestrian walkway and get an agreement at a cost not to exceed \$7,000.
 - It is our intent to include this construction as part of the Stage VI Phase 1 contract.
 - R.W. Armstrong submitted a cost to coordinate and design this walkway in the amount of \$26,000. The board deferred doing this work until a later date due to financial constraints. (See Stage VI-I Engineering Report.)

D. Stage VIII Trails:

- 1. We received a letter from NICTD on October 15th, 2001 (dated October 9th) indicating problems with the location of our trail on their R/W under I-80/94.
 - They feel it is a safety concern and suggested we reroute our trail along their R/W to 173rd Street.
 - LCRBDC is currently contacting NICTD to do a review with the Corps, and SEH (Corps engineer) to discuss their request.

 - B. We sent a letter to INDOT on September 4th informing them that all design for any work that would impact our project should be coordinated with the COE (through Imad Samara) in order to comment on engineering.
 - C. We submitted a memo to the INDOT consulting engineer on November 30th, 2001, enclosing plats of the area & requesting information that would be part of a right of entry.

STAGE III DRAINAGE REMEDIATION PLAN.

1. We received 100% plans and specs for review from the COE on November 1st, 2001, requesting comments no later than November 30th, 2001. We submitted our comments to the COE on December 3rd, 2001. (Comments available upon request.)

2. COE estimates approx. \$1 million to do this work. \$800,000 for ditches and pumps, \$50,000 to engineer an 18,500 GPM pump station West of Grant St. & remainder toward work with the City of Gary.

- 3. The scope of this project is to include the following:
 - A. Lift stations West of Grant to remediate drainage problems due to Stage III construction
 - B. East Reach remediation lift station for interior drainage
 - We received comments from the GSD on December 4th, 2001, that were submitted to the COE for their review.
 - Issue #19 questions the COE design of 1500 GPM sufficient. They feel good GPM would be needed. (This could be a \$600,000 difference in cost.)

- C. East Reach remediation demolition
- D. Extending the combination sewer East of Grant Street, North to our line of protection
- 4. Tentative schedule is to advertise January 2002 and start construction in May of 2002.

STATUS (Stage IV Phase 1 - North) Cline to Burr (North of the Norfolk Southern Railroad:

- IV-1 (North) The drainage system from Colfax to Burr Street North of the Norfolk Southern RR.
 - Current contract amount \$3,013,910.52
 - Original contract amount \$2,708,720.00

• Amount overrun - \$305,109 (11%)

- 2. The final inspection was held on August 30th, 2001, and tools & manuals were given to the LCRBDC.
- 3. Will still require "as-built" drawings, and minor punch list items need to be completed.

STATUS (Stage IV Phase 1 - South) (South of the N.S. RR.)

- 1. Dyer Construction was low bidder. Given 450 days to complete
 - Current contract amount \$4,218,104.53
 - Original contract amount \$3,862,736.65
 - Amount overrun \$355,367 (9.2%)
- 2. Overall construction is now complete. The COE did a preliminary walk-thru with the contractor on October 17th, 2001, to get a preliminary punch list.
 - When these items are completed, we will do a final inspection of this segment anticipate this in December, 2001
 - · An inspection is anticipated for Fall, 2001
- 3. WIND Radio facilities:
 - A. Three outstanding issues need to be addressed that are new or existing.
 - 1. WIND has damaged the completed levee segment and suggest that the cost to repair this could be done as part of the expense of repairing their ground system.
 - We received a letter from the Army Corps Calumet office, along with photographs, dated December 17th, 2000 showing the levee before and and after the damage.
 - The contractor completed their responsibility and the COE suggests we take necessary actions to repair.
 - 2. We received a letter from WIND on November 29th, 2001, along with receipts 8-9 and cost breakdowns, requesting an increase for this utility re-locate from their original estimate of \$37,960.70 to \$53,900.
 - We sent a letter to the COE and to Lou Casale on December 13th, 2001, /O suggesting coordination to resolve these issues.
 - 3. The remaining issue concerns their letter of September 17th, 2001, requesting that we fence an "open pond" we created for drainage as well as fencing to secure their property from trespassers to get river access.
 - At our October board meeting, the commissioners made and approved a motion to fence the pond but not their property.
- 4. We received modification #16 for a supplemental cost to the contract in the amount /2 of \$32,510.56, which increases the total contract to \$4,218,104.52.

STATUS (Stage IV Phase 2A) Burr to Clark – Lake Etta:

- 1. Dyer Construction-95% complete.
 - Current contract amount \$3,504,445.80
 - Original contract amount \$2,473,311.50
 - Amount overrun \$1,031,134 (42%)
- 2. The North Burr Street stormwater pumping station has been completed.
 - A. A meeting was held on February 8th, 2000, with the COE and GSD to review design and installation of auxiliary power hook-up with a portable generator.

- B. All electric has been completed, the metal building is installed, and the total project is done except for some minor trench settling. We will be scheduling an inspection with GSD/WREP in early **January 2002**.
- C. Austgen Electric is the contractor.

STATUS (Stage IV Phase 2B) Clark to Chase

- The final inspection was held with the COE and Dyer Construction on July 23rd, 2001, and we received the O&M Manuals.
- 2. Project money status:
 - Current contract amount \$1,938,357.86

 - Amount overrun \$408,000 (27%)

STATUS (Betterment Levee – Phase 1) E.J. & E. Railroad to, and including Colfax North of the NIPSCO R/W (Drainage from Arbogast to Colfax, South of NIPSCO R/W):

- 1. The bid opening was held on May 9th, 2000
 - The low bidder is Dyer Construction.
 - Current contract amount \$2,228,652.16
 - Original contract amount \$2,074,072.70
 - Amount overrun \$113,604.62 (6%)
- 2. The final inspection was held on August 30th, 2001, with minor punch list items to be completed. Manuals and tools, and "as-built" drawings will be turned over to LCRBDC.
- 3. The drainage ditch north of the Mansards is having sloughing problems that should be corrected when Burr Street Phase II is completed.

STATUS (Betterment Levee – Phase 2) Colfax to Burr Street, then North NSRR, then East (North of RR R/W) ½ between Burr and Clark, back over the RR, then South approx. 1,400 feet:

- 1. We wrote a letter to the COE on May 21st, 2001, requesting final information for all utility re-locates in order that we may proceed with agreements.
 - We received an email from the COE on November 20th, 2001, indicating that this project is currently on hold and that they are concentrating their efforts on other segments.
- 2. We received plans and specifications from the COE on July 11th, 2001. A "plan-in-hand" meeting was held on July 31st, 2001, and our final comments were submitted to the COE on August 7th, 2001. (These comments are available upon request).
- 3. The projected government estimate for this project is approximately \$3.6 million.
 - LCRBDC needs to review spending through 2003 (this biennium) to establish
 priorities. The \$5.5 million may not allow this construction if land acquisition and
 utility re-locates in the West Reach exceed original cost estimates.
 - We included the Land Acq., utility re-locates, and our portion for construction into this biennium, but are pursuing the possibility of making this project part of the flood control project (not a betterment).

STATUS (Stage V Phase 1) Wicker Park Manor:

- Project completed on September 14, 1995.
 Dyer Construction Contract price \$998,630
- 2. Phillips Pipeline directional bore under the existing levee is currently being engineered by Phillips. Awaiting their design and cost by June, 2001.
 - As of March 23, 2001, a temporary hold has been put on this engineering request due to current funding restrictions. This will be done at a later date as part of the V-2 construction.

STATUS (Stage V Phase 2):

- 1. With the approved \$5.5 million for this biennium and with \$5.5 million assumed for the next biennium, we project a fall, 2005 advertising date.
- 2. A utility coordination meeting was held on November 16th, 2000 with all pipelines, utilities, etc. that will be impacted in the NIPSCO corridor West of Kennedy Ave.
 - A. We have received cost information from the pipeline companies to do the work necessary to accommodate I-walls. The total cost in this corridor and for 2 directional bores west of the RR will total approximately \$1.1 million.
 - B. We made a request to NIPSCO on August 22nd for copies of all subordinated agreements with other pipelines to allow our attorney to review their responsibilities to repair or modify their pipelines.
 - We received copies of (3) of the (9) different pipelines on August 31st.
- 3. We received a letter of request from North Township on July 9th, 2001 to re-align the levees adjacent to Hart Ditch further Westward to allow more room to develop property on the Wicker Park Golf Course.
 - Currently, the design will require 300' between center lines of levees, the layout has the levee on Wicker Park approx. 220' East of Hart Ditch and the levee on the Munster side approx. 80' West of Hart Ditch.
 - This is due, on the Munster side, to the limitations of real estate, and to the proximity of residential dwellings.
 - The meeting with Munster and North Township was held on July 19th, 2001. It appears North Township will try to minimize impacts to the Munster side if the COE might do some considerations.
- 4. We requested an email from Highland/COE regarding drainage concerns with INDOT in the area around and adjacent to the Tri-State Bus terminal.
 - A meeting was held with the COE, INDOT, LCRBD, North Township and Highland on June 14th, 2001, to review these drainage concerns.
 - A potential exists to partner between Highland, North Township and INDOT to build a pump station in the ditch area West of Tri-State.
 - We received a letter from the COE dated May 24th, 2001 (on July 3rd) indicating to INDOT that the ponding in this are is likely to be substantially greater and it would be in the best interest of the community if they would include a pumping unit.
 - We are gathering information on hydrology from Highland, North Township (Wicker Park) to be provided by the COE and INDOT. (Ongoing)
 - We received a call from North Township (Greg Cvitkovich) on December 19th,
 2001, requesting a meeting with the COE, INDOT, and Highland to review and discuss the status of INDOT's proposal in this area.

- 5. We received a request from the COE on September 26th, 2001, to obtain additional information on the pipeline corridor for locations and elevations.
 - We received a quote from GLE for the survey work at a cost not to exceed \$3500.
 - We met <u>Badger Daylighting</u> on October 18th, 2001, to review scope of work. We received a letter on November 12th, 2001, indicating they could do the pipe exposing for \$12,200 during dry conditions and \$37,000 in wet conditions.

STATUS (Stage V Phase 3) Woodmar Country Club:

- 1. Refer to Land Acquisition report for status of appraisal process and revised schedule.
 - As per our June 7th, 2000 partnering meeting, the schedule shows a March 2002 advertising date. This date will be pushed back due to funding restrictions even if we get the \$5.5 million for this biennium. The construction sequence due to hydrology will push construction back in the schedule.
- 2. Appraisal work ongoing (refer to Land Acquisition report).
- 3. This project will be done after all other construction between Cline Ave. and Northcote is completed due to hydrology concerns with installing the control structure as part of the project.

STATUS Stage VI - Phase 1 (Cline to Kennedy - North of the river, and Kennedy to Liable, South of the river.):

- 1. Legal descriptions North of the river have been completed by GLE, and legals South of the river have been completed by DLZ.
 - A. Legals have been done for Hammond, HSD, and Hammond Parks between the Highlands Apartments and the S.E. Hessville Pump Station.
 - These lands include approx. 62 acres of ownership and when the appraisal is completed, we will coordinate with Hammond for turnover of these lands for our project.
 - B. Highland properties were completed (plats & legals) by DLZ and given to Dale Kleszynski (appraiser) at our July 19th, 2001 Real Estate meeting. (Approx. 62 acres.) See Land Acq. Report.
 - C. Preliminary appraisal work has been completed for the Kennedy Industrial Park area (see Land Acq. Report).
- 2. A letter was sent to the COE on November 15th, 2001, requesting a list of all utilities, locations, costs, etc. in order that we may proceed with utility re-location agreements in a timely manner.
- 3. We received a proposal from R.W. Armstrong dated December 4th, 2001, for a cost /3-/4 of \$26,000, to design a cantilevered pedestrian walkway onto the East side of the existing Kennedy Ave. bridge.
 - At our December 6th, 2001 board meeting, the commissioners suggested we put this on hold due to financial constraints.
- 4. A letter was sent to Krosan Enterprises on November 28th, 2001, requesting a written response to indicate how much area would be needed to allow traffic flow South of his building.

STATUS Stage VI - Phase 2 (Liable to Cline - South of the river.):

- 1. Rani Engineering was awarded the A/E contract by the COE in January 2000. (They are out of St. Paul, Minnesota.)
- 2. We received a letter from INDOT to Rani Engineering on January 8, 2001 indicating their concerns regarding culverts & recreational proposals.
 - A. A meeting was held with RANI, the COE, INDOT, and the LCRBDC on April 11, 2001 to review these and other engineering issues.
 - INDOT agreed we could cross Cline Avenue at the existing light at Highway Avenue. (See Recreation Report).
 - B. We are at the 100% level of review some issues to still be resolved. The COE agreed we would have one more opportunity to review and comment prior to their finalization of plans & specs.
 - Highland submitted a letter to the COE on August 20th requesting re-consideration of design regarding storm sewers and drainage changes & responsibilities to modify and construct.
 - C. We received plans & specs. From the COE on November 29th, 2001, requesting /6 that we complete our review no later than January 11, 2002.
 - We distributed (2) sets to Highland for their review.
 - D. It is the intent of the COE to advertise this segment simultaneously and separately from Stage VI 1.

STATUS (Stage VII) Northcote to Columbia:

- 1. The final contract with <u>Earth Tech</u> to do the A/E work for this stage/phase of construction was signed and submitted by the COE on December 21st, 1999.
- 2. We received a request for a 75% review from the COE on January 16, 2001 along with their comments and responses to our 50% review.
 - We sent a letter to the COE on February 1 with comments to their 75% submittal indicating a number of concerns and requesting another review opportunity prior to the 100% review.
- 3. A public meeting will be scheduled with Hammond and Munster. (This will be after the 75% BCOE review process). Tentatively the end of January, 2002.

STATUS (Stage VIII) Columbia to the Illinois State Line):

- 1. The A/E award was given to S.E.H. (Short, Elliot & Henderson Inc.)
- 2. A public meeting was held at the Wicker Park Social Center for Hammond and Munster on November 28th, 2001, to gather public information and to answer questions.
- 3. A letter was sent to the Lake County Highway Dept. on November 20th, 2001, requesting that our concrete closure slab on Hohman Ave. be incorporated into their bridge project which is scheduled to start on April 1st, 2002.
 - A pre-construction meeting is scheduled for January 3rd, 2001 at the Lake County Highway office to review design and scheduling.
- 4. We received a letter from NICTD dated October 9th, 2001 with the engineering/recreational design concerns in the area under I-80/94.
 - We have been working on a meeting with NICTD and the COE to discuss their letter of October 9th, 2001.

East Reach Remediation Area - North of I-80/94, MLK to I-65:

- 1. Project cost information
 - Current contract amount \$1,873,784.68
 - Current contract amount \$1,657,913.00
 - Amount overrun \$215,971 (13%)
- 2. A final inspection was held with the COE and Dyer Construction on July 23rd, 2001 and we received copies of the O&M manuals.
 - We received "as-built" drawings from the COE on June 25th and distributed to the city of Gary on June 27th.

Mitigation (Construction Portion) for "In Project" Lands:

- 1. We received copies of the final submittal of the drawings and specifications for 29th & Hanley, Black Oak, and Chase St. wetlands sites from the Conservation Design Forum on September 28th, 2001 (dated September 24th, 2001).
 - LCRBDC did not have the opportunity to coordinate at the 50% level.
- 2. The COE is anticipating to advertise this portion of construction in December 2001, and start construction in May of 2002.
- 3. This includes 29th & Hanley, areas between levees West of Chase and East of Clark.
 - There may be potential to eliminate 29th & Hanley due to economic justification or zoning objections by the City of Gary. (See Land Acq. Report.)
- 4. They are proposing to use the most qualified contractor rather than bidding it out. The contractor will need a botanist.
 - This is projected to be a \$1 million contract our portion at 25% is \$250,000, and the Corps anticipates we need to contribute 60% this biennium (approx. \$150,000).
- 5. A letter was written by Mayor King to Colonel Roncoli on November 10th, 2001, requesting Gary lands be used for mitigation rather than Hobart Marsh (asking for a reevaluation).

West Reach Pump Stations - Phase 1A:

- 1. The four (4) pump stations that are included in this initial West Reach pump station project are Baring, Walnut, S. Kennedy, and Hohman/Munster.
- 2. Low bidder was Overstreet Construction. Notice to proceed was given on November 7th, 2000 700 work days to complete (Oct. 2002)

 - Original contract amount \$4,638,400.00

 - Baring started July 2001, Hohman/Munster in August 2001, and S. Kennedy and Walnut in September 2001. Anticipated completion is October 2002.

 - NIPSCO will engineer each station, provide a cost estimate, enter into agreements with HSD for upgrades & with the LCRBDC for any utility relocates.
- 7. Received (2) administrative changes for additional money available for payment in /8-/9 the amount of \$200,000 money now available \$1,031,592.59.

West Reach Pump Stations - Phase 1B:

- 1. The Two (2) pump stations included in this contract are S.E. Hessville (Hammond), and 81st Street (Highland). Overall project is 99% complete.
 - A. A final inspection was held for both stations on September 18th, 2001. We received a letter that day listing key turnover items.
 - B. We received an email from the COE on November 7th, 2001, indicating that we will be receiving the final O&M Manuals in the near future.
- 2. Thieneman Construction from Griffith, IN was the successful bidder.
 - Current contract amount \$2,120,730.12
 - Original contract amount \$1,963,400.00
 - Amount overrun \$157,330 (9%)
- 3. We received the last status report from the COE on November 26th, 2001.

North Fifth Avenue Pump Station:

- 1. The low bidder was Overstreet Construction
 - Current contract amount \$2,387,500.0
 - Original contract amount \$2,387,500.00
 - Amount overrun none
- 2. A pre-construction meeting was held on May 21st with Overstreet Construction, town of Highland, COE, NIPSCO, and the LCRBDC.
 - There are currently 10 pumps and all of these will be replaced with new and will be coordinated with the town of Highland.
- 3. We received the last status report from the COE on November 26th, 2001.

4. We received a request for an administrative change in the amount of \$100,000, which makes money available for payment \$250,000.

GENERAL:

- 1. Utility Re-locations:
 - A. On June 20, 2001, a utility coordination meeting was held with the LCRBDC and the COE to discuss utility status and how to track each relocation.
 - Compensability for utility relocations was discussed and milestones were presented for review to Don Valk and the COE on March 20, 2001.
 - Another meeting needs to be scheduled to update status of all West Reach utilities as well as compensability.
- 2. The Gary Sanitary District/White River Environmental Group has had engineering/hydrology and maintenance concerns with our design and installation for flood protection that they feel needs to be addressed prior to them agreeing to any O&M responsibility. (See Land Management Report.)
 - The COE was requested to answer these final (5) issues in early September, 2001

 no reports as of December 27th, 2001.
- 3. An Engineering Committee meeting was held on November 13th, 2001, to review a tentative list of cost savings issues for our project.
 - A. These included reviews of our rights and entitlements of our 75' drainage easement, re-channeling of the river to lessen impacts to property owners, hydrology changes near the state line due to Cady Marsh modifications and the Thornton Quarry, and reconsideration of our approach to Woodmar Country Club.
 - B. We sent a letter to the COE on December 6th, 2001 enclosing information, maps, sketches, and some FDM 5 data that are pertinent to our "tentative list of cost saving items".
 - We asked the COE to review these and then to provide "VE" information to Jim Flora to allow us to provide economic justification.

Dear Mr. Pokrajak,

Pursuant to your request, the only issues that WIND has remaining are:

Payment of the invoice we recently sent.

The invoice you received represents the expenses WIND has incurred so far.

This also included a detailed report of the construction activities that occurred at the WIND site to replace the ground system.

The second issue is <u>the condition of the soil and grass following replacement of</u> our copper radials, as brought to our attention by Ed Karwatka.

This could not be avoided. We waited until Dyer construction gave us the go ahead before starting. When we got started, the weather was very bad. Because of almost constant rain, mud and the steepness of the levee, more soil and grass was disturbed than we'd expected. We originally attempted get the radials installed with the tractor we'd planned and ended up using a bulldozer. The tractor could not get through the mud or up the steep sloops of the muddy levee. We had to constantly pump water to keep the area workable. Essentially we were working in a river bed. CBC, under the circumstances made the best of the situation and got it done. The WIND signal is back to normal. If there are repairs that need to be done to the levee, please do this as part of the expense of repairing our ground system. We are done with the repairs to the ground system that would go over the levee.

All things considered we have been happy with the cooperation enjoyed during this project and hope we can help wrap this up soon.

This letter documents the Corps of Engineers' previous telephone calls to you regarding damages to the levee and turf in the vicinity of the WIND facility. As background information, the Contractor has substantially completed work on the levee in this area. Two photographs showing the condition of the levee on October 15, 2001 are attached. (The date on which the photograph was taken is shown in yellow text in the lower right corner.) These photographs were taken before WIND operators installed the radial underground wires from the transmission towers across the levee. As shown on these photographs, the levee was complete and the turf in good condition in mid-October 2001.

Seven photographs taken on December 13, 2001, after WIND operators installed the radial underground wires across the levee, are also attached. As shown on these photographs, the topsoil surface and the turf of the levee have been damaged.

The Contract-required work was acceptably completed, but the levee was subsequently damaged, apparently by WIND operators. It is requested that you take the appropriate actions to restore the levee to its acceptable condition, as documented in the October 15, 2001 photographs.

Dear Dan:

As per our agreement dated January 1, 2000, the Little River Calumet Basin Development Commission (LCRBDC) is to reimburse WIND for expenses relating to ground system replacement/repairs. We had provided an estimate, which was approximately \$37,960.70, however this estimate was based upon the assumption that we could dig a trench at the edge of your work area and cut the ground wires, to prevent the destruction of the entire run of copper back to the towers, from being removed along with the topsoil. This trench rendered useless when it was subsequently covered by your contractor. In addition, we did mention that we did believe that the costs for replacement would be greater than set forth in the original estimate. Most of the work had to be redone due to the yearlong wait. We were set back due to the Army Corps delaying this project for nearly ayear. As a result, we experienced many complications and weather delays. I have attached the myoice we received from CBC Engineering for this project, which totals \$53,900. I have also included an invoice from Metal Services, which is the cost of the copper wire and copper strap for the ground system replacement project.

Costs of the Project:

The original budget was set up using standard costs for ground system repairs. We were set back due to the year long Army Corps delay, many complications and weather delays. The only way we could bill this project was on time and materials.

1) Machine costs.

There were multiple machines used during this project. Each machine is listed and what costs were associated with it.

- a) D-6 LGP Dozer: used for clearing of site and covering of radials and trench. Also used to pull plow over burm. Total costs for 6 weeks \$ 1,750.00 weekly = \$ 10,500.00
- b) New Holland Excavator: Used for digging the cable and strap trench and culvert trench. Total costs for 3 weeks \$ 2,200.00 weekly = \$ 6,600.00

- d) Cat Vibrator Roller: Used for compacting the road and creating a good base for our copper strap run. A very critical machine. Total costs for 6 weeks \$ 1,450.00 weekly = \$ 8,700.00
- e) Kubota M6800 Tractor: Used for plowing in the radials. Total cost for 7 weeks \$ 650.00 weekly = \$4,550.00

Total for Equipment Rental = \$ 34,500.00 Labor rate of \$ 2,000.00 weekly for 7 weeks = \$ 14,000.00 Total for rock, 20 loads at \$250.00 a load (\$10.00 a ton) = \$ 5,000.00



He is in the process of stripping unsuitable material from the surface and is anticipating to have \pm 600,000 additional cubic yards of clay available to northwest Indiana. Dear Dan:

This information is a status report regarding our work towards implementing the stormwater storage facility located along the Spring Street Ditch within the Town of Schererville known as the "Hartsdale Pond Project".

As you know, we have been involved in pushing this project for nearly ten (10) years and want to bring you up to date with the following:

- 1. We did in fact award a contract to Dyer Construction for the installation of duplex pumps that includes a 10' diameter wet-well and all appurtenances thereof. These purnps were designed to discharge no more than 90 cfs, the allowable rate for flows in downstream Spring Street Ditch.
- Also included in Dyer Construction's contract is a concrete spillway at the 2. upstream end of Spring Street Ditch into the pond. This is designed to allow heavy rainfall events to spill over from the low-flow channel of the ditch into the pond for storage. The pumps will activate and discharge after the pond reaches the designed high-elevation. Also, the pumps will operate in order to keep the pond dry after rain events.
- We have received required permits on November 15, 2001, and have 3. notified the contractor to commence the work. Said work should be complete in early March of 2002.
- After the pumps have emptied the pond, we will take elevations and trench the existing bottom to eliminate any pockets of standing water. We anticipate said trench work will help dry out the pond bottom.

- Also, after the pond has been pumped out, we will order more soil borings in hopes that the results will verify the material's quality as dike material for the Little Calumet River Project.
- 6. Preliminary estimates of the quantity of the material is some 200,000 cubic yards. This amount will be verified at such time we take field elevations and consider the soils' evaluation.
- Weather and other unforeseen conditions permitting, we are hoping for a completed project within the next twelve (12) months.
- 8. We presently are preparing an Interlocal Agreement between the Towns of Highland and Schererville with respect to future maintenance and utility costs that will cover operating this facility. The Lake County Drainage Board will be responsible for the pond maintenance, since it has regulated drain status (easement) of the pond and Spring Street Ditch. Said easement was granted to the Drainage Board from the owner (fee simple), the Lake County Board of Commissioners.

I look forward to this project's completion and hope that the materials can be used for the Little Calumet River Project, so that we can continue to expand the storage capabilities of our pond.

Significant dollars have been expended from or through the Lake County Drainage Board, the Lake County Board of Commissioners, the Lake County Surveyor's Office, the Build Indiana Fund and now, soon from the towns of Highland and Schererville, all to make this project a reality. We look forward to your participation also.

LAND MANAGEMENT REPORT For meeting on Thursday, January 3, 2002

(Information in this report is from November 28, 2001 – December 26, 2001)

NON-PROJECT LAND MANAGEMENT

- A. Handicapped-Accessible Park
 - 1. The remaining segment of Charles Agnew Park will probably be completed next year and a dedication ceremony held in the summer.
- B. Gleason Park-Driving Range
 - A meeting was held with Gary Parks and Recreation on June 19th, 2001, to review and discuss scheduling, funding, and scope of work for a driving range North of 30th Ave., West of Broadway.
 - We have received no correspondence about this issue from Gary Parks & Recreation.

PROJECT RELATED LAND MANAGEMENT

- A. O&M (Project manual review/accepting completed segments)
 - 1. It is anticipated to start accepting levee segments (after inspections are completed and found acceptable) as early as February, 2002.
 - 2. The LCRBDC agreed that we would initially inspect and accept the projects on an individual basis to relieve the contractor of his obligations. However, we will require a procedure to mutually sign off with the COE to accept O & M responsibility. (COE currently working on this procedure.)
 - 3. LCRBDC is currently working on O&M responsibility tables to establish each task and who will do each item.
 - A spreadsheet for Gary has been completed that shows all tasks, frequency of tasks, and locations.
 - We are currently gathering information for costs and who might accept responsibility for each task.
- B. Mitigation (entire project area)
 - 1. We received a letter from COE stating that DC616 (29th and Hanley) <u>is</u> an acquisition, LCRBDC should proceed. Dan is waiting for a letter from Gary Mayor Scott King to state Gary's position on accepting a large parcel of land for mitigation at 29th and Hanley or if Gary would rather see more economic development in that area.
- C. Emergency Management/River Monitoring
 - 1. It is our understanding that the GSD is currently monitoring river levels as part of the emergency response participation plan.
 - Currently, the LCRBDC has completed review of GSD/WREP concerns that have not been addressed and submitted these to the COE for their input.
 - Refer to Item "F" in this Report regarding operations and maintenance.
 - 2. LCRBDC has reviewed COE mapping which shows locations of road closings, sandbagging, and emergency response locations. A plan to coordinate each community flood event response is currently being formulated with information

received from the COE in the final O&M Manual received on November 1st, 2001. (Ongoing)

3. We submitted a letter to all representatives for Gary on November 16th, 2001, with a copy of our installation procedure for their review. Upon receipt of comments, we will then distribute a final copy to all parties.

- A letter was sent to Carmen Wilson (GSD Director) on November 9th, 2001, thanking GSD for their cooperation for the October 12th, 2001 closure structure coordination, and also requesting their assistance with cleaning out the other trench on Chase St.
- The GSD cooperated again by using WREP to clean out both closure trenches on Chase and on 35th, and re-organized closure material in the storeroom on December 18th and 19th.
- 4. We sent a memo to Gene Kellar on December 5th, 2001, to begin coordination for an instructional video for closure structures.
- D. Lake Erie Land Company (The Great Konomick)
 - 1. No next meeting date has been scheduled.
- E. LAMAR Advertising Company
 - 1. At the October 4th Commission meeting, Arlene Colvin stated the city of Gary's position on the 2 proposed new signs at I-65 & I-80/94 would not be in compliance with city codes (1200' between signs) and the city would decline their request.
 - We received an email from Gary on December 6th, 2001, indicating that Lamar should coordinate with the Gary Zoning Department and that the approved distance between billboards is 500'.
 - LCRBDC wrote a letter to Lamar on December 13th, 2001, suggesting that 3 rather than we act as liaison, that they coordinate with Gary themselves.
 - 2. LCRBDC received a phone call from Lamar on December 18th, 2001, asking if the LCRBDC would approve them building these signs on our property if they could get Gary approval.
 - It will be presented as a motion at our January 3rd, 2002 meeting if we would not approve, then they would not spend money to pursue.
- F. Gary Sanitary District (White River Environmental Partners (WREP)) O&M
 - LCRBDC has gathered information from the COE to address both engineering and
 maintenance questions raised by GSD/WREP. We completed a current status sheet that
 will be reviewed & forwarded to them for discussion as part of an agenda to turn over
 O&M to them.
- We wrote a letter to the COE on November 14th, 2001, enclosing our request to them dated September 6th, 2001, addressing the 5 remaining GSD/WREP concerns that have not been answered in writing. We cannot proceed with any O&M issues nor accept any levee segments until these issues are addressed.
- G. The Griffith levee west of the EJ&E RR to Cline Avenue has been completed as well as the Colfax road raise. We will be scheduling a meeting with Griffith to discuss their participation in maintaining and operating these items future no later than mid-December.

- H. Portions of west reach pump stations in Hammond and Highland are being turned over to their respective communities. Representatives of the Hammond and Highland Sanitary Districts are inspecting with the COE and Contractor and signing off as owner.
 - 1. Currently working with Highland (John Bach/Mike Griffin) to put together an agreement whereby the community/LCRBDC/COE can mutually sign off for construction acceptance, but the community assumes O&M responsibility. (Ongoing)
 - Submitted to Attorney Casale on October 5, 2001 for review & comments.

1. REVIEW OF THE 28 NOVEMBER 2001 PUBLIC MEETING STAGE VIII

a. The Good – It was agreed that the LCRBDC video makes a good presentation of explaining the flood project, however, the fiscal figures are out-of-date and need to be updated. Judy will call Chris Sloan of Merging Pictures to see if he can update the video.

(ACTION: Judy/LCRBDC)

- b. The Bad It was agreed that the AE for Stage VIII (SEH representative) Jeff Davis gave too technical explanations. Landowners could not easily understand his answers. Imad would like to have a meeting with the AE of Stage VII (Earth Tech) before the upcoming Stage VII public meeting to discuss the proper way to communicate to landowners. Imad will call Earth Tech and set-up a meeting. (ACTION: Imad/COE)
- c. The Ugly It was agreed that the worst part of the evening occurred when Dan and Imad were standing at the podium answering questions and the SEH representative stood behind them and shook his head answering the same questions opposite to what Dan and Imad said. This should not happen again.

2. SCHEDULE DATE FOR THE STAGE VII PUBLIC MEETING

a. Imad suggested a probable date for the Stage VII meeting as Wednesday, 30 January 2002, 6:30 to 9 pm. Judy will call Wicker Park and ask to reserve the social center for that day and time. Tuesday 29 January or Thursday 31 January are alternative dates.

(ACTION: Judy/LCRBDC)

3. ACQUISITION STATUS

a. 29th and Hanley DC 616 (about 20 acres used for in-project Mitigation) – Dan is still trying to get a letter from the City of Gary stating its position on the Burr Street/80-94 intersection. If Gary wants economic development in that area, instead of large tracts used for mitigation, Gary should put it in writing.

(ACTION: Dan/LCRBDC)

- b. Burr Street Phase 2 (Colfax to Clark Road) Lou, Jim, and Judy will be meeting on 12 December to discuss the remaining problem acquisitions.
- c. East Reach (Cline to I-65) Lou, Jim, and Judy will be meeting on 12 December to discuss the reaming problem acquisitions.
- d. East Reach Remediation (MLK I-65) Lou has written his letter to the Lake County Commissioners asking for 12 of the remaining 27 properties. Those 12 are on the tax sale. Judy and Lorraine are putting together information packets of the remaining 15 properties to get to Angie so Uniform Land Offers can be mailed ASAP.
- e. Stage VI As title work comes in Judy and Loraine are putting together information packets to get to Angie so offers can be sent to landowners.

 (ACTION: Jim, Lorraine, Lou, Judy /LCRBDC on b.c.d.e)

4. Crediting

Chrystal returned several crediting packets to Loraine. Erika reported that the computer Dbase tracking system is officially discontinued. Corps Real Estate is looking into a system already in use by other local sponsors. LCRBDC will not be able to input data. It will be a view only for LCRBDC and Lorraine will do crediting manually. She will use a written form. The new system will be on-line in March.

(ACTION: Chrystal and Erika/COE)

Chrystal also reported that by Corps federal regulations all future crediting submittals must be "per tract." Copies of invoices for title work, appraisals, surveys, anything pertinent to land acquisition must be in the submitted file. Presently only title work and appraisal bills are in the file. Surveying bills are submitted on a yearly basis. Sandy will start inserting survey bills in DC numbered files.

Corps rules also require that a copy of the recorded warranty deed with final title or a copy of the easement agreement with a title update showing the LCRBDC recorded easement also be included in crediting submittals. Lou questioned if LCRBDC easements are insured. He will call the title companies for an answer.

(ACTION: Lou, Sandy, and Lorraine/LCRBDC)

5. STAGE IV-1 NORTH PROBLEM

- a. Judy reported that Lou has received a call from an attorney representing a landowner on 30th Place in Black Oak. Judy has spoken with the landowner. LCRBDC has a wide drainage ditch at the back portion of their long, narrow lot, but not quite to the back property line. A Wolverine pipeline runs underground between the ditch and the back property line and it's covered with grass. The landowner(s) on 30th are having difficulty getting to the grass to cut it. The ditch is too wide to cross. Judy asked the Corps to consider that:
 - 1. LCRBDC re-purchase the present easement area in fee to control the grass cutting problem,
 - 2. LCRBDC receive credit for the fee purchase.

Erika and Chrystal said they would research Corps regulations, however, they doubt if LCRBDC can receive credit twice on the same parcel. Judy will write a letter explaining the problem and asking for a ruling.

(ACTION: Judy/LCRBDC and Chrystal and Erika/COE)

6. REMAINING EAST REACH PROBLEM DC 517

a. DC 517 owners Maurice and Maude Cobb need to be relocated, however, they have heavily encroached on adjacent Gary Parks & Recreation property with goats, chickens, horses, and several outbuildings. This will be a difficult relocation and Judy asked Chrystal and Erika if there might be a possibility of eliminating this property from the project. Chrystal and Erika said that if the LCRBDC can show a change in the land elevation then eliminating this parcel would be possible.

(ACTION: COE and LCRBDC)
